4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Section 504.510(d), Transportation Code, is
6	amended to read as follows:
7	(d) This section applies only to:
8	(1) an owner of a golf cart who resides:
9	$\overline{\text{(A)}}$ [\frac{(1)}{1}] on real property that is owned or under
10	the control of the United States Corps of Engineers and is required
11	by that agency to register the owner's golf cart under this chapter;
12	and
13	(B) $[(2)$ in a county that borders another state
14	and has a population of more than 110,000 but less than 111,000; or
15	(2) a golf cart to be operated on municipal streets or
16	county roads under Section 551.981.
17	SECTION 2. Subchapter F, Chapter 504, Transportation Code,
18	is amended by adding Section 504.511 to read as follows:
19	Sec. 504.511. SIDE-BY-SIDE UTILITY VEHICLES. (a) The
20	department shall issue specialty license plates for an eligible
21	side-by-side utility vehicle.
22	(b) The fee for issuance of the license plates is \$10.
23	(c) This section does not authorize the operation of a

side-by-side utility vehicle on a public road where it is otherwise

- 5 SECTION 3. Section 551.001, Transportation Code, is amended
- 6 to read as follows:
- 7 Sec. 551.001. PERSONS AFFECTED. Except as provided by
- 8 Subchapters [Subchapter] C and Z, this chapter applies only to a
- 9 person operating a bicycle on:
- 10 (1) a highway; or
- 11 (2) a path set aside for the exclusive operation of
- 12 bicycles.
- SECTION 4. Chapter 551, Transportation Code, is amended by
- 14 adding Subchapter Z to read as follows:
- 15 SUBCHAPTER Z. MISCELLANEOUS PROVISIONS
- Sec. 551.981. OPERATION OF GOLF CARTS AND SIDE-BY-SIDE
- 17 UTILITY VEHICLES. (a) In this section:
- 18 (1) "Golf cart" has the meaning assigned by Section
- 19 502.001.
- 20 (2) "Side-by-side utility vehicle" means a motor
- 21 <u>vehicle that is not a golf cart and is:</u>
- (A) equipped with side-by-side seating for the
- 23 use of the operator and a passenger;
- 24 (B) designed to propel itself with at least four
- 25 tires in contact with the ground;
- 26 (C) designed by the manufacturer for off-highway
- 27 use only; and

- (D) designed by the manufacturer primarily for 1
- 2 farming, ranching, or utility work.
- (b) The governing body of a municipality or the 3
- 4 commissioners court of a county, as applicable, may allow the
- operation of a golf cart or a side-by-side utility vehicle on 5
- 6 streets in the municipality or on roads in the unincorporated area
- 7 of the county.
- 8 (c) The operator of a golf cart or a side-by-side utility
- 9 vehicle may operate the vehicle as provided by Subsection (b) if:
- (1) a slow-moving vehicle emblem, as defined by 10
- Section 547.001, is attached to the vehicle; 11
- 12 (2) the vehicle is equipped with headlights and
- taillights which are illuminated; 13
- 14 (3) the operator holds a Class A, B, C, or M driver's
- 15 license, as defined by Sections 521.081-521.084 or a commercial
- 16 driver's license under Chapter 522;
- 17 (4) the vehicle is registered under Section 504.510 or
- 18 504.511;
- 19 (5) the operator establishes financial responsibility
- for the vehicle under Section 601.051; and 20
- 21 (6) the vehicle is equipped with a horn that complies
- with Section 547.501. 22
- SECTION 5. This Act takes effect September 1, 2007. 23
