No. 273 requires its school bus drivers to have the 1 (1)2 qualifications required by and to be certified in accordance with 3 standards established by the Department of Public Safety; and 4 (2) uses only those school buses or mass transit 5 authority buses in transporting 15 or more public school students 6 that meet or exceed safety standards for school buses established 7 under Section 34.002[, Education Code]. SECTION 4. Section 44.031(b), Education Code, is amended to 8 9 read as follows: Except as provided by this subchapter, in determining to 10 (b) whom to award a contract, the district shall [may] consider: 11 12 (1) the purchase price; the reputation of the vendor and of the vendor's 13 (2) 14 goods or services; 15 (3) the quality of the vendor's goods or services; (4) the extent to which the goods or services meet the 16 district's needs; 17 the vendor's past relationship with the district; (5) 18 the impact on the ability of the district to comply 19 (6) rules relating to historically underutilized 20 with laws and 21 businesses; (7) the total long-term cost to the district to 22 acquire the vendor's goods or services; and 23 24 (8) any other relevant factor specifically listed in 25 the request for bids or proposals. Sec. 44.0331. MANAGEMENT FEES UNDER CERTAIN COOPERATIVE 1 2 PURCHASING CONTRACTS. (a) A school district that enters into a purchasing contract valued at \$25,000 or more under Section 3 4 44.031(a)(5), under Subchapter F, Chapter 271, Local Government 5 Code, or under any other cooperative purchasing program authorized 6 for school districts by law shall document any contract-related fee, including any management fee, and the purpose of each fee under 7 8 the contract.

9 <u>(b) The amount, purpose, and disposition of any fee</u> 10 <u>described by Subsection (a) must be presented in a written report</u> 11 <u>and submitted annually in an open meeting of the board of trustees</u> 12 <u>of the school district. The written report must appear as an agenda</u> 13 <u>item.</u>

14 (c) The commissioner may audit the written report described
15 by Subsection (b).

16 SECTION 6. The change in law made by Section 44.031(b), 17 Education Code, as amended by this Act, and Section 44.0331, 18 Education Code, as added by this Act, applies only to a contract 19 entered into on or after the effective date of this Act. A contract 20 entered into before the effective date of this Act is governed by 21 the law in effect immediately before that date, and that law is 22 continued in effect for that purpose.

23 SECTION 7. This Act takes effect immediately if it receives 24 a vote of two-thirds of all the members elected to each house, as 25 provided by Section 39, Article III, Texas Constitution. If this 26 Act does not receive the vote necessary for immediate effect, this 27 Act takes effect September 1, 2007.
