4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Subchapter Z, Chapter 25, Education Code, is
6	amended by adding Section 25.902 to read as follows:
7	Sec. 25.902. CONTACT BETWEEN STUDENT WHO COMMITS ASSAULT
8	AND STUDENT VICTIM. (a) This section applies only to:
9	(1) a student who:
LO	(A) has been convicted of an offense described by
L1	Section 37.006(a)(2)(B) or 37.007(a)(2)(A);
L2	(B) has been found by a court to have engaged in
L3	delinquent conduct on the basis of conduct described by Section
L4	37.006(a)(2)(B) or 37.007(a)(2)(A); or
L5	(C) has been accused of committing an offense
L6	described by Section 37.006(a)(2)(B) or 37.007(a)(2)(A) or of
L7	engaging in conduct that contains the elements of such an offense,
L8	and has had a protective order issued against the student in
L9	connection with the alleged offense or conduct; and
20	(2) a student who is the victim of conduct described by
21	Subdivision (1).
22	(b) A student who is a victim to whom Subsection (a)(2)
23	applies and who is assigned to the same campus as the student who

- 1 counselor at the campus, or in the student's school district if the
- 2 campus does not have a counselor, of the offense or other conduct
- 3 and request that the counselor attempt to ensure limited contact
- 4 between the victim and the other student in the manner provided by
- 5 Subsection (c).
- 6 (c) For purposes of this subsection, "parent" includes a
- 7 person standing in parental relation. On receiving a request under
- 8 <u>Subsection (b) from a student who is a victim, the counselor shall</u>
- 9 suggest to the parent of the student who committed the offense or
- 10 <u>engaged in the conduct that the parent attempt to transfer the</u>
- 11 student to or enroll the student in another school. If the
- 12 <u>student's parent refuses or is unable to transfer the student to or</u>
- 13 <u>enroll the student in another school, the counselor shall develop a</u>
- 14 plan for ensuring that the student and the student who is the victim
- 15 have limited contact during the school day and during any
- 16 <u>extracurricular activities.</u> The counselor shall coordinate with
- 17 the parent of the student who committed the offense or engaged in
- 18 the conduct and the parent of the victim separately in developing
- 19 the plan.
- 20 SECTION 2. This Act applies beginning with the 2007-2008
- 21 school year.
- 22 SECTION 3. This Act takes effect immediately if it receives
- 23 a vote of two-thirds of all the members elected to each house, as
- 24 provided by Section 39, Article III, Texas Constitution. If this
- 25 Act does not receive the vote necessary for immediate effect, this
- 26 Act takes effect September 1, 2007.
