Sec. 502.455. TEMPORARY PERMIT FOR A VEHICLE PURCHASED IN A PRIVATE PARTY TRANSACTION. (a) A purchaser or transferee may obtain from the department a temporary single-trip permit to operate a motor vehicle:

(1) that is subject to registration in this state;

from which the license plates and the registration insignia have been removed as required by Section 502.451; and

(3) that is not authorized to travel on a public roadway because the required license plates and the registration insignia are not attached to the vehicle.

The department may issue the permit in accordance with this section.

(c) A permit issued under this section is valid for one trip between the point of origin and the destination and those intermediate points specified in the permit.

(d) A permit issued under this section may not be valid for

longer than a five-day period.

Sec. 502.457. DEPARTMENT SUPPORT. (a) The department may into a system design contract to determine the feasibility and benefits of an electronic registration and title system to facilitate the registration and titling of motor vehicles under this subchapter.

(b) Subsection (a) may not be construed to authorize the department to implement a system or enter into a contract for the implementation of a system that affects the issuance of temporary license tags under Chapter 503.

SECTION 3. Section 520.021, Transportation Code, is repealed.

SECTION 4. This Act takes effect January 1, 2008.
