A BILL TO BE ENTITLED

AN ACT

- relating to the regulation of air conditioning and refrigeration contracting; providing an administrative penalty.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Section 1302.002, Occupations Code, is amended
- 6 by adding Subdivisions (5-a), (5-b), and (17) to read as follows:
- 7 (5-a) "Air conditioning and refrigeration technician"
- 8 means a person who assists a licensed air conditioning and
- 9 refrigeration contractor in performing air conditioning and
- 10 refrigeration maintenance work.
- 11 <u>(5-b) "Certified technician" means a registered</u>
- 12 <u>technician who has completed a certification examination.</u>
- 13 (17) "Registered technician" means an air
- 14 conditioning and refrigeration technician who is registered with
- 15 the department.

- SECTION 2. Section 1302.101, Occupations Code, is amended
- 17 by adding Subsection (e) to read as follows:
- (e) The department may examine any criminal conviction,
- 19 guilty plea, or deferred adjudication of an applicant for issuance
- 20 or renewal of a license, including by obtaining any criminal
- 21 history record information permitted by law.
- 22 SECTION 3. Section 1302.263, Occupations Code, is amended
- 23 to read as follows:
- Sec. 1302.263. LIMITATION ON LICENSE HOLDER OR REGISTERED

- 1 <u>TECHNICIAN</u>. A person licensed under this chapter may not:
- 2 (1) perform or offer or attempt to perform an act,
- 3 service, or function that is:
- 4 $\underline{\text{(A)}}$ [\(\frac{\((1)\)}{\(1)\)}] defined as the practice of engineering
- 5 under Chapter 1001, unless the person holds a license under that
- 6 chapter;
- 7 $\underline{\text{(B)}}$ [$\frac{\text{(2)}}{\text{)}}$] regulated under Chapter 113, Natural
- 8 Resources Code, unless the person holds a license or is exempt by
- 9 rule under that chapter; or
- 10 $\underline{\text{(C)}}$ [$\frac{\text{(3)}}{\text{)}}$] defined as plumbing under Chapter
- 11 1301, unless the person holds a license under that chapter; or
- 12 (2) use the services of a person who is not a
- 13 registered technician or a licensed air conditioning and
- 14 refrigeration contractor to assist in the performance of air
- 15 conditioning and refrigeration maintenance work.
- SECTION 4. Section 1302.401(a), Occupations Code, is
- 17 amended to read as follows:
- 18 (a) A person is subject to the denial of an application,
- imposition of an administrative penalty under Subchapter F, Chapter
- 20 51, or disciplinary action under Section 51.353 if the person:
- 21 (1) violates this chapter or a rule adopted under this
- 22 chapter; or
- 23 (2) <u>violates</u> [is convicted of an offense under] a
- 24 municipal ordinance adopted under Section 1302.303.
- 25 SECTION 5. Section 1302.402, Occupations Code, is amended
- 26 to read as follows:
- Sec. 1302.402. ADMINISTRATIVE PROCEDURES. A proceeding for

- 1 the denial of a license or registration application or disciplinary
- 2 action and an appeal from that proceeding are governed by Chapter
- 3 2001, Government Code.
- 4 SECTION 6. Chapter 1302, Occupations Code, is amended by
- 5 adding Subchapter K to read as follows:
- 6 SUBCHAPTER K. AIR CONDITIONING AND REFRIGERATION TECHNICIANS
- 7 Sec. 1302.501. REGISTRATION REQUIRED. (a) A person may
- 8 <u>not act or offer to act as an air conditioning and refrigeration</u>
- 9 technician unless the person is registered under this subchapter.
- 10 (b) A registration is valid throughout the state.
- 11 Sec. 1302.502. RULES. The executive director shall adopt
- 12 rules:
- 13 (1) providing for the registration of technicians as
- 14 prescribed by this subchapter;
- (2) adopting standards of conduct for registered
- 16 <u>technicians and license holders under this subchapter; and</u>
- 17 (3) establishing fees for issuance and renewal of a
- 18 registration.
- 19 Sec. 1302.503. SUPERVISION REQUIREMENTS FOR REGISTRANTS.
- 20 An air conditioning and refrigeration technician must be supervised
- 21 by an air conditioning and refrigeration contractor licensed under
- this chapter.
- Sec. 1302.504. APPLICATION; FEE. (a) An applicant for
- 24 registration must submit an application on a form prescribed by the
- 25 commission.
- 26 (b) The completed application must be accompanied by the
- 27 application fee.

- 1 Sec. 1302.505. ISSUANCE AND TERM OF REGISTRATION. (a) On
- 2 receipt of a completed application, the department shall register
- 3 an applicant who meets the requirements of this subchapter.
- 4 <u>(b) A registration is valid for one year from the date of</u> 5 issuance.
- 6 Sec. 1302.506. TEMPORARY REGISTRATION. (a) An applicant
- 7 for registration may request a temporary registration. The
- 8 executive director shall issue a temporary registration that
- 9 <u>expires on the 21st day after the date of issuance to an applicant</u>
- 10 who meets the qualifications for temporary registration.
- 11 (b) The commission shall adopt rules providing for the
- 12 issuance of a temporary registration under this section, including
- 13 the qualifications and fee required for the registration.
- 14 Sec. 1302.507. RENEWAL OF REGISTRATION. To renew a
- 15 registration, a registered technician must:
- (1) submit a renewal request on a form prescribed by
- 17 <u>the executive director; and</u>
- 18 (2) pay the required renewal fee.
- 19 Sec. 1302.508. CERTIFIED TECHNICIAN. A registered
- 20 technician may be certified by the department and use the
- 21 <u>designation "certified technician" if the registered technician:</u>
- 22 <u>(1) completes an application for certification on a</u>
- 23 form prescribed by the executive director;
- 24 (2) pays the application fee; and
- 25 (3) provides the department with proof that the
- 26 registered technician successfully completed a nationally
- 27 recognized and administered certification examination or another

- 1 examination of equal or greater difficulty approved by the
- 2 <u>department</u>.
- 3 SECTION 7. Not later than December 31, 2007, the Texas
- 4 Commission of Licensing and Regulation shall adopt rules
- 5 implementing Subchapter K, Chapter 1302, Occupations Code, as added
- 6 by this Act.
- 7 SECTION 8. (a) Except as provided by Subsection (b) of
- 8 this section, this Act takes effect September 1, 2007.
- 9 (b) Sections 1302.501 and 1302.503, Occupations Code, as
- 10 added by this Act, take effect June 30, 2008.
