- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

- 5 SECTION 1. Chapter 37, Code of Criminal Procedure, is 6 amended by adding Article 37.15 to read as follows:
- 7 Art. 37.15. TEXAS CAPITAL PUNISHMENT COMMISSION
- 8 Sec. 1. CREATION. The Texas Capital Punishment Commission
- 9 is created.

- 10 Sec. 2. DUTIES. (a) The commission shall study capital
- 11 <u>punishment in this state, concentrating</u> particularly on issues
- 12 relating to the legal representation of inmates in capital cases,
- 13 the certainty of the guilt of individuals convicted in capital
- 14 cases, and the sufficiency of appellate review of convictions in
- 15 capital cases.
- 16 (b) After completing the study, the commission shall
- 17 propose legislation to correct any inequities in the capital
- 18 punishment process in this state.
- 19 Sec. 3. COMPOSITION. (a) The commission is composed of
- 20 <u>nine members appointed by the governor, three of whom must be</u>
- 21 appointed from a list of candidates submitted to the governor by the
- 22 speaker of the house of representatives and three of whom must be
- 23 appointed from a list of candidates submitted to the governor by the
- 24 lieutenant governor. The governor may reject the candidates on a

- 1 list and require a new list to be submitted.
- 2 (b) Each member serves at the pleasure of the governor.
- 3 <u>(c) The governor shall designate a member to serve as</u> 4 presiding officer.
- 5 (d) Each member of the commission must be generally
- 6 experienced in criminal justice matters. In addition, there must
- 7 <u>be at least one member of the commission who is experienced in the</u>
- 8 prosecution of capital cases, one who is experienced in the defense
- 9 of capital cases, and one who is experienced as a trial judge in
- 10 capital cases. The governor shall ensure that the commission
- 11 members have the qualifications required by this subsection.
- 12 Sec. 4. REIMBURSEMENT. A member of the commission is not
- 13 entitled to compensation but is entitled to reimbursement for the
- 14 member's travel expenses as provided by Chapter 660, Government
- 15 Code, and the General Appropriations Act.
- Sec. 5. ASSISTANCE. The Texas Legislative Council and the
- 17 Legislative Budget Board shall assist the commission in performing
- 18 the commission's duties.
- 19 Sec. 6. SUBMISSION. The commission shall submit the
- 20 proposed legislation described by Section 2 to the lieutenant
- 21 governor and the speaker of the house of representatives not later
- 22 than <u>December 1, 2008.</u>
- Sec. 7. INITIAL APPOINTMENTS. The governor shall make the
- 24 appointments to the commission as soon as possible after the
- 25 effective date of this article.
- Sec. 8. MORATORIUM. The state may not execute an inmate on
- or after the effective date of this article and before September 1,

- Sec. 9. OTHER LAW. The commission is not subject to Chapter
- 3 <u>2110, Government Code.</u>
- 4 Sec. 10. ABOLITION. The commission is abolished on January
- 5 <u>1, 2009, and this article expires on that date.</u>
- 6 SECTION 2. This Act takes effect September 1, 2007.
