| 8  | (a) The board of regents of The University of Texas System   |
| 9  | may charge each student enrolled at The University of Texas at El  |

| 11 | semester or summer session]. The fee may be used only for financing,   |
| 12 | constructing, operating, maintaining, and improving new and  |
| 13 | existing recreational sports facilities and programs at The  |
| 14 | University of Texas at El Paso.  |
| 15 | (a-1) A fee imposed under this section may not exceed:   |
| 16 | (1) \$70 per student for a term or semester of 10 weeks  |
| 17 | <u>or longer; or</u>   |
| 18 | (2) \$50 per student for any other term or semester.   |
| 19 | (a-2) Notwithstanding Subsection (a-1), for a term or  |
| 20 | semester before the 2009 fall semester, a fee imposed under this   |
| 21 | section may not exceed \$20 per student for a semester or summer   |
| 22 | session. This subsection expires September 1, 2009.  |
| 23 | (c) The recreational facility fee may not be <u>increased</u>  |
| 24 | [ <del>levied</del> ] unless the <u>amount of the increase</u> [ <del>fee</del> ] is approved [ <del>and</del> |

the amount of the fee is set] by <u>a</u> majority vote of those students participating in a general student election called at The University of Texas at El Paso for that purpose.

4 SECTION 2. The change in law made by this Act applies to 5 fees charged beginning with the 2007 fall semester. A fee charged 6 for a term or semester before the 2007 fall semester is covered by 7 the law in effect immediately before the effective date of this Act, 8 and the former law is continued in effect for that purpose.

9 SECTION 3. This Act takes effect immediately if it receives 10 a vote of two-thirds of all the members elected to each house, as 11 provided by Section 39, Article III, Texas Constitution. If this 12 Act does not receive the vote necessary for immediate effect, this 13 Act takes effect September 1, 2007.
