L3	(b) A candidate for certification under this section must:
L4	(1) hold a baccalaureate or advanced degree from ar
L5	institution of higher education;
L6	(2) have significant management and leadership
L7	experience, as determined by the board of trustees of the school
L8	district that will employ the person under the temporary
L9	certificate; and
20	(3) perform satisfactorily on the appropriate

22	(c) A school district may require that a person who is
23	employed by the district and who holds a certificate issued under

this section complete a training program.

(d) A certificate issued to a person under this section is 1 2 valid only in the school district in which the person is initially 3 employed after receiving the certificate. 4 (e) A certificate issued under this section: (1) expires on the third anniversary of the date on 5 6 which the certificate was issued; and 7 (2) is not renewable. 8 (f) The board shall issue a standard certificate to a person 9 who holds a temporary certificate issued under this section if the 10 school district employing the person under the t<u>emporary</u> 11 certificate: 12 (1) has employed the person for at least three years in the capacity for which the person seeks a standard certificate; and 13 (2) has recommended the person to the board and 14 15 favorably reviewed, primarily using objective measures of student 16 performance and improvement in the district, the person's 17 performance. (g) A school district employing a person who holds a 18 temporary certificate issued under this section must provide the 19 person with intensive support during the person's first year of 20 21 employment with the district, including: 22 (1) mentoring; and (2) intensive, high-quality professional development. 23

- SECTION 2. Section 21.054, Education Code, is amended by amending Subsection (b) and adding Subsection (c) to read as follows:
- 4 Continuing education for principals must be based on an 5 individual assessment of the knowledge, skills, and proficiencies necessary to perform successfully as a principal, as identified in 6 7 Section 21.046. As part of a principal's compliance with 8 continuing education requirements under this section, a principal 9 must attend advanced management training courses or programs as 10 prescribed by board rule. An individualized professional growth plan shall be developed as a result of the assessment and shall be 11 used exclusively for professional growth purposes. The assessment 12 results and the growth plan may only be released with the approval 13 14 of the principal assessed. Except as provided by Section 21.059, 15 each certified principal shall participate in the assessment process and professional growth activities at least once every five 16 17 years.
 - (c) The board, in consultation with business schools, departments, or programs at institutions of higher education, shall propose rules to govern the approval and accountability of advanced management training courses or programs required under this section. In proposing a rule under this section, the board shall require that a person conducting a course or program have recognized expertise in business management.
