A BILL TO BE ENTITLED AN ACT 1 2 relating to regional health care programs for employees of small 3 employers. BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: 4 SECTION 1. Subtitle C, Title 2, Health and Safety Code, is 5 6 amended by adding Chapter 75 to read as follows: CHAPTER 75. REGIONAL HEALTH CARE PROGRAMS FOR EMPLOYEES OF SMALL 7 8 EMPLOYERS 9 SUBCHAPTER A. GENERAL PROVISIONS Sec. 75.001. PURPOSE. The purpose of this chapter is to: 10 11 (1) improve the health of employees of small employers 12 and their families by improving the employees' access to health care and by reducing the number of those employees who are 13 14 uninsured; (2) reduce the likelihood that those employees and 15 16 their families will require services from state-funded entitlement programs such as Medicaid; 17 (3) contribute to economic development by helping 18 small businesses remain competitive with a healthy workforce and 19 health care benefits that will attract employees; and 20 21 (4) encourage innovative solutions for providing and 22 funding health care services and benefits. 23 Sec. 75.002. DEFINITIONS. In this chapter: (1) "Employee" means an individual employed by an 24

The term includes a partner of a partnership and the 1 2 proprietor of a sole proprietorship. 3 (2) "Governing body" means the commissioners courts of 4 the counties participating in a regional health care program or the governing body of the joint council, nonprofit entity exempt from 5 6 federal taxation, or other entity that operates the program in 7 accordance with this chapter. (3) "Regional health care program" means a regional 8 health care program established for the benefit of the employees of 9 small employers under Subchapter B. 10 (4) "Small employer" means a person who employed an 11 12 average of at least two employees but not more than 50 employees on business days during the preceding calendar year and who employs at 13 14 least two employees on the first day of the plan year. [Sections 75.003-75.050 reserved for expansion] 15 16 SUBCHAPTER B. REGIONAL HEALTH CARE PROGRAM 17 Sec. 75.051. MULTICOUNTY COOPERATION. The commissioners courts of two or more counties may, by joint order, establish or 18 19 participate in a regional health care program under this 20 subchapter. 21 Sec. 75.052. GOVERNANCE OF PROGRAM. (a) A regional health care program may be operated subject to the direct governance of the 22 commissioners courts of the participating counties, or the program 23 24 may be operated by a joint council, tax-exempt nonprofit entity, or 25 other entity that: 26 (1) operates the program under a contract with the

27 <u>commissioners courts; or</u>

(2) is an entity in which the counties participate or 1 2 that is established or designated by the commissioners courts to 3 operate the program. 4 (b) In selecting an entity described by Subsection (a)(1) or (2) to operate a regional health care program, the commissioners 5 6 courts of the participating counties shall require, to the extent 7 possible, that the entity be authorized under federal law to accept donations on a basis that is tax-deductible or otherwise 8 9 tax-advantaged for the contributor. Sec. 75.053. OPERATION OF PROGRAM. A regional health care 10 program provides health care services or benefits to the employees 11 of participating small employers who are located within the 12 boundaries of the participating counties. A program may also 13 14 provide services or benefits to the dependents of those employees. 15 Sec. 75.054. PARTICIPATION BY SMALL EMPLOYERS; SHARE OF 16 COST. The governing body may establish criteria for participation 17 in a regional health care program by small employers, the employees of the small employers, and their dependents. The criteria must 18 require that participating employers and participating employees 19 pay a share of the premium or other cost of the program. 20 21 Sec. 75.055. ADDITIONAL FUNDING. (a) A governing body may accept and use a gift, grant, or donation from any source to operate 22 the regional health care program and to provide services or 23

- 25 (a-1) A governing body may apply for and receive a grant
 26 under Subchapter D to support a regional health care program. This
 27 subsection expires September 1, 2009.

1	(b) A governing body shall actively solicit gifts, grants,
2	and donations to:
3	(1) fund services and benefits provided under the
4	regional health care program; and
5	(2) reduce the cost of participation in the program
6	for small employers and their employees.

8	SUBCHAPTER C. HEALTH CARE SERVICES AND BENEFITS
9	Sec. 75.101. ALTERNATIVE PROGRAMS AUTHORIZED; PROGRAM
10	OBJECTIVES. In developing a regional health care plan, a governing
11	body may provide health care services or benefits as described by
12	this subchapter or may develop another type of program to
13	accomplish the purposes of this chapter. A regional health care
14	program must be developed, to the extent practicable, to:
15	(1) reduce the number of individuals without health
16	benefit plan coverage within the boundaries of participating
17	counties;
18	(2) address rising health care costs and reduce the
19	cost of health care services or health benefit plan coverage for
20	small employers and their employees within the boundaries of the
21	participating counties;
22	(3) promote preventative care and reduce the incidence
23	of preventable health conditions, such as heart disease, cancer,
24	diabetes, and infants with low birth weight;
25	(4) promote efficient and collaborative delivery of
26	health care services;
27	(5) serve as a model for the innovative use of health

1	information technology to promote efficient delivery of health care
2	services, reduce health care costs, and improve the health of the
3	community; and
4	(6) provide fair payment rates for health care
5	providers.
6	Sec. 75.102. HEALTH BENEFIT PLAN COVERAGE. (a) A regional
7	health care program may provide health care benefits to the
8	employees of small employers by purchasing or facilitating the
9	purchase of health benefit plan coverage for those employees from a
10	health benefit plan issuer, including coverage under:
11	(1) a small employer health benefit plan offered under
12	Chapter 1501, Insurance Code;
13	(2) a standard health benefit plan offered under
14	Chapter 1507, Insurance Code; or
15	(3) any other health benefit plan available in this
16	state.
17	(b) The governing body may form one or more cooperatives
18	under Subchapter B, Chapter 1501, Insurance Code.
19	(c) Notwithstanding Chapter 1251, Insurance Code, an
20	insurer may issue a group accident and health insurance policy,
21	including a group contract issued by a group hospital service
22	corporation, to cover the employees of small employers
23	participating in a regional health care program. The group
24	policyholder of a policy issued in accordance with this subsection
25	is the governing body or the designee of the governing body.
26	(d) A health maintenance organization may issue a health
27	care plan to cover the employees of small employers participating

1	in a regional health care program. The group contract holder of a
2	contract issued in accordance with this subsection is the governing
3	body or the designee of the governing body.
4	Sec. 75.103. OTHER HEALTH BENEFIT PLANS OR PROGRAMS. To the
5	extent authorized by federal law, the governing body may establish
6	or facilitate the establishment of self-funded health benefit plans
7	or may facilitate the provision of health benefit coverage through
8	health savings accounts and high-deductible health plans.
9	Sec. 75.104. HEALTH CARE SERVICES. (a) A regional health
10	care program may contract with health care providers within the
11	boundaries of the participating counties to provide health care
12	services directly to the employees of participating small employers
13	and the dependents of those employees.
14	(b) A governing body that operates a regional health care
15	program under this section may require that participating employees
16	and dependents obtain health care services only from health care
17	providers that contract to provide those services under the program
18	and may limit the health care services provided under the program to
19	services provided within the boundaries of the participating
20	<u>counties.</u>
21	(c) A governing body operating a regional health care
22	program operated under this section is not an insurer or health
23	maintenance organization and the program is not subject to
24	regulation by the Texas Department of Insurance.

3	(2) "Executive commissioner" means the executive
4	commissioner of the commission.
5	Sec. 75.152. GRANT PROGRAM. (a) The executive
6	commissioner may establish a grant program to support the initial
7	establishment and operation of a regional health care program as a
8	demonstration project in one or more regions of this state.
9	(b) In selecting grant recipients, the executive
10	commissioner shall consider the extent to which the regional health
11	care program proposed by the applicant accomplishes the purposes of
12	this chapter and meets the objectives established under Section
13	75.101.
14	(c) The commission shall establish performance objectives
15	for a grant recipient and shall monitor the performance of the grant
16	recipient.
17	Sec. 75.153. REVIEW OF DEMONSTRATION PROJECT; REPORT. Not
18	later than December 1, 2008, the commission shall complete a review
19	of each regional health care program that receives a grant under
20	this subchapter and shall submit to the governor, lieutenant
21	governor, and speaker of the house of representatives a report that
22	includes:
23	(1) an evaluation of the success of regional health
24	care programs in accomplishing the purposes of this chapter; and
25	(2) the commission's recommendations for any
26	legislation needed to facilitate or improve regional health care
27	programs.

1	Sec. 75.154. EXPIRATION. This subchapter expires September
2	<u>1, 2009.</u>
3	SECTION 2. The heading to Subtitle C, Title 2, Health and
4	Safety Code, is amended to read as follows:
5	SUBTITLE C. <u>PROGRAMS PROVIDING</u> [INDIGENT] HEALTH CARE <u>BENEFITS AND</u>
6	SERVICES
7	SECTION 3. This Act takes effect immediately if it receives
8	a vote of two-thirds of all the members elected to each house, as
9	provided by Section 39, Article III, Texas Constitution. If this
10	Act does not receive the vote necessary for immediate effect, this
11	Act takes effect September 1, 2007.
