8	(a) The general election for officers of a city that borders the
9	Gulf of Mexico, has a population of more than 230,000 according to
10	the 1980 census, and held its general election for officers in 1987
11	on the first Saturday in April may be held on any Saturday in April
12	in odd-numbered years.
13	(b) An independent school district located wholly or partly
14	in a city holding an election authorized under Subsection (a) may
15	hold its general election for trustees on the same date as a joint
16	election with the city.
17	SECTION 2. Section 11.0581(a), Education Code, is amended
18	to read as follows:
19	(a) An election for trustees of an independent school
20	district shall be held on the same date as:
21	(1) the election for the members of the governing body
22	of a municipality located in the school district; [or]
23	(2) the general election for state and county
24	officers; or

1	(3) the election for the members of the governing body
2	of a hospital district, if the school district:
3	(A) is wholly or partly located in a county with a
4	population of less than 30,000 that is adjacent to a county with a
5	population of more than three million; and
6	(B) held its election for trustees jointly with
7	the election for the members of the governing body of the hospital
8	district before May 2007.
9	SECTION 3. Not later than December 31, 2007, the board of
10	trustees of an independent school district may:
11	(1) change the date on which it holds its general
12	election for trustees to allow the district to hold its election
13	jointly with a municipality holding an election under Section
14	41.0051, Election Code, or a hospital district as described by
15	Section 11.0581(a)(3), Education Code; and
16	(2) adjust the terms of office of trustees to conform
17	to the change of the election date made under Subdivision (1) of
18	this section.
19	SECTION 4. This Act takes effect September 1, 2007.
