(d) A municipality to which this section applies may not 1 2 reduce the amount of revenue that an arts center that receives funds under Subsection (b) spends for a purpose described by Section 3 4 351.101(a)(3) to an amount that is less than the amount of revenue spent by the arts center for those purposes during the fiscal year 5 6 of the arts center preceding the effective date of this section. If the municipality reduces the funding of the arts center under 7 Subsection (b), the art center's required funding amount for 8 purposes described by Section 351.101(a)(3) is also reduced by a 9 10 proportional amount. (e) An arts center that receives funds under Subsection (b) 11 shall include a website address that contains a link to area hotels 12 and lodging options in the municipality on all materials produced 13 14 for the purposes of Section 351.101(a)(3). 15 (f) This section expires September 1, 2022. 16 SECTION 2. This Act takes effect immediately if it receives a vote of two-thirds of all the members elected to each house, as 17 provided by Section 39, Article III, Texas Constitution. If this 18 Act does not receive the vote necessary for immediate effect, this 19 Act takes effect September 1, 2007. 20
