4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Subchapter Z, Chapter 51, Education Code, is
6	amended by adding Section 51.953 to read as follows:
7	Sec. 51.953. STUDENT HEALTH CENTER. (a) In this section:
8	(1) "Health benefit plan" means any health benefit
9	plan regulated under the Insurance Code, including:
10	(A) an individual or group health insurance
11	policy; or
12	(B) an evidence of coverage issued by a health
13	maintenance organization.
14	(2) "Institution of higher education" has the meaning
15	assigned by Section 61.003.
16	(b) The governing board of an institution of higher
17	education may require the institution's student health center to
18	assist a student or other person entitled to obtain health care
19	services from the health center in receiving benefits under a
20	health benefit plan by filing or having a claim filed with the
21	health benefit plan issuer on behalf of the student or other person.
22	(c) An institution of higher education on behalf of the
23	institution's student health center located within the geographic
24	service area of a health benefit plan may contract with the health

2	to students or other persons entitled to obtain health care
3	services from the health center who are covered by the plan.
4	(d) Amounts received by an institution of higher education
5	from a health benefit plan issuer as a result of a claim filed with
6	the issuer by or on behalf of the institution's student health
7	center are institutional funds under Section 51.009 and may be used
8	only for the construction, improvement, operation, or maintenance
9	of the student health center or to increase or enhance the services
10	offered by the student health center. It is the intent of the
11	legislature that those amounts be in addition to other amounts of
12	money allocated to the student health center and those other
13	amounts not be reduced.
14	(e) Not later than January 15 of each year, the governing
15	board of an institution of higher education shall report to the
16	legislature the amount of the following sources of income for
17	funding the institution's student health center:
18	
	(1) money received from student fees and charges;
19	(2) money received from the operation of the student
20	health center's pharmacy;
21	(3) money received as a result of a claim filed by or
22	on behalf of the institution's student health center under a health
23	benefit plan sponsored by or administered on behalf of the
24	institution; and
25	(4) money received as a result of a claim filed by or
26	on behalf of the institution's student health center under a health
27	benefit plan other than a plan sponsored by or administered on

benefit plan issuer to provide health care services under the plan
