11	which this chapter applies relating to hiring the individual, or
12	relating to retaining the individual if the entity or work reduces
13	its workforce, may appeal the decision by filing a written
14	complaint with the governing body of the public entity or public
15	work under this section.
16	(b) The governing body of a public entity or public work
17	that receives a written complaint under Subsection (a) shall
18	respond to the complaint not later than the 15th business day after
19	the date the governing body receives the complaint. The governing
20	body may render a different hiring decision than the decision that
21	is the subject of the complaint if the governing body determines
22	that the veteran's preference was not applied.
23	SECTION 2. Section 657.008(a), Government Code, is amended
24	to read as follows:

H.B. No. 1275 1 (a) A public entity shall file quarterly with the 2 comptroller a report that states:

3 (1) the percentage of the total number of employees
4 hired by the entity during the reporting period who are persons
5 entitled to a preference under this chapter; [and]

6 (2) the percentage of the total number of the entity's 7 employees who are persons entitled to a preference under this 8 chapter; and

9 (3) the number of complaints filed with the governing 10 body of the entity under Section 657.010 during that quarter and the 11 number of those complaints resolved by the governing body.

SECTION 3. Section 657.010, Government Code, as added by this Act, applies only to an employment decision made by a public entity or a public work to which Chapter 657, Government Code, applies, on or after the effective date of this Act. An employment decision made before the effective date of this Act is governed by the law in effect immediately before that date, and the former law is continued in effect for that purpose.
