20	(b-1) A person may park a commercial motor vehicle or leave
21	the vehicle parked on a street for which signs are posted as
22	provided by Subsection (c) if [unless] the commercial motor

residential subdivision or performing work in the subdivision; and (2) remains parked in <u>or adjacent to</u> the subdivision only for the period necessary to complete the transportation or work.

5 (c) The residents of a residential subdivision may petition a county or municipality in which the subdivision is located for the 6 7 posting of signs prohibiting the overnight parking of a commercial 8 motor vehicle in the subdivision or on a street adjacent to the 9 subdivision and within 1,000 feet of the property line of a residence, school, place of worship, or park. The petition must be 10 signed by at least 25 percent of the owners or tenants of residences 11 in the subdivision. Not more than one person for each residence may 12 sign the petition, and each person signing must be at least 18 years 13 14 of age. Promptly after the filing of a petition meeting the 15 requirements of this subsection and subject to Subsection (d), the county or municipality receiving the petition shall post the signs. 16 17 The signs must:

(1) be posted<u>:</u>

19 <u>(A)</u> at each entrance of the subdivision through 20 which a commercial motor vehicle may enter the subdivision or 21 within the subdivision if there is not defined entrance to the 22 subdivision; or

(B) on a street adjacent to the subdivision; and (2) state, in letters at least two inches in height, that overnight parking of a commercial motor vehicle is prohibited in the subdivision or on a street adjacent to the subdivision.
