- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 6 SECTION 1. Section 841.001, Government Code, is amended by
- amending Subdivisions (7) and (18) and adding Subdivision (7-a) to 7
- read as follows: 8
- (7) "Credited service" means the number of months of 9
- prior, [and] current, and optional service ascribed to a member in 10
- 11 the retirement system.
- (7-a) "Director" means the person appointed as 12
- director under Section 845.202. 13
- 14 (18) "Optional group term life [Supplemental death
- benefit] program" means the voluntary, employer-funded optional 15
- 16 death benefit program established under Subchapter F, Chapter 844.
- SECTION 2. Section 841.004, Government Code, is amended to 17
- read as follows: 18
- Sec. 841.004. POWERS, [AND] PRIVILEGES, AND IMMUNITIES. 19
- (a) The retirement system is a governmental entity and has the 20
- 21 powers, privileges, and immunities of a corporation, as well as the
- powers, privileges, and immunities conferred by this subtitle. 22
- 23 (b) The board of trustees, director, investment officer,
- 24 and employees of the retirement system are not liable for any action

- 1 taken or omission made or suffered by them in the good faith
- 2 performance of any duty in connection with any program or benefit
- 3 administered by the retirement system.
- 4 SECTION 3. Section 841.008, Government Code, is amended by
- 5 amending Subsections (a) and (b) and by adding Subsection (c-1) to
- 6 read as follows:
- 7 (a) The board of trustees may accept an application for any
- 8 benefit under this subtitle that is signed on behalf of a person
- 9 entitled to the benefit by:
- 10 (1) an appointed guardian of the person and estate of
- 11 the person; or
- 12 (2) an attorney in fact authorized to act on behalf of
- 13 the person by a written power of attorney that provides that the
- 14 power is not revoked by disability of the person, except that an
- 15 attorney in fact who is not the person's spouse may not select a
- 16 benefit in which the attorney in fact or a direct ancestor or lineal
- 17 descendant of the attorney in fact is a named beneficiary, unless
- 18 the attorney in fact designates as the person's beneficiary:
- 19 (A) the same individuals, with the same share of
- 20 the benefit that each would have received if the person had died
- 21 <u>immediately before the beneficiary designation by the attorney in</u>
- 22 <u>fact; or</u>
- 23 <u>(B) all individuals who bear the same</u>
- 24 relationship to the attorney in fact, with the same share of the
- 25 benefit that each would have received [each individual who would be
- 26 entitled to the entire benefit] if the person had died intestate.
- 27 (b) If it is made to appear to the director by affidavit of a

- licensed physician that a person entitled to a benefit is not 1 2 mentally capable of managing the person's own affairs, and if the director reasonably believes [it is further established to the 3 4 satisfaction of the director] that the estate of the person is 5 insufficient to justify the expense of establishing a guardianship, or continuing a guardianship after letters of guardianship have 6 expired, then until current letters of guardianship are filed with 7 8 the retirement system, the director may make payment of any annuity 9 or other benefit:
- 10  $\hspace{1cm}$  (1) to the spouse of the person, as trustee for the 11 person;  $[\frac{or}{c}]$
- 12 (2) to an individual or entity actually providing for 13 the needs of and caring for the person, as trustee for the person; 14 or
- 15 (3) to a public agency or private charitable

  16 organization providing assistance or services to the aged or

  17 incapacitated that agrees to accept and manage the payment for the

  18 benefit of the person as a trustee [until current letters of

  19 quardianship are filed with the retirement system].
- (c-1) If the director reasonably believes that the 20 21 individual or entity accepting benefits for the person has breached a fiduciary duty owed to the person or is failing to act in the 22 interest of or for the benefit of the person and the person may 23 24 suffer personal or financial harm as a result, the retirement system, on giving notice to the individual or entity receiving 25 26 payments on behalf of the person, may cease making payments to the individual or entity. Thereafter, the system may make payment of 27

- any annuity or other benefit in a manner provided by Subsection (b).
- 2 This subsection does not apply if a court of competent jurisdiction
- 3 has appointed the individual or entity accepting benefits for the
- 4 person.
- 5 SECTION 4. Section 842.001(d), Government Code, is amended
- 6 to read as follows:
- 7 (d) Subject to the approval of the board of trustees, an
- 8 electing subdivision under this section may begin participation in
- 9 the retirement system on the <u>date specified</u> [first day of any month
- 10 designated] by the subdivision's governing body.
- 11 SECTION 5. Section 842.002, Government Code, is amended to
- 12 read as follows:
- 13 Sec. 842.002. RULES FOR PARTICIPATING SUBDIVISIONS. The
- 14 board of trustees may adopt rules concerning:
- 15 (1) notices, information, and reports the board of
- 16 trustees requires from a subdivision that elects to participate in
- 17 the retirement system;
- 18 (2) the time that a subdivision that elects to
- 19 participate in the retirement system may begin participation and
- 20 the actions that subdivision may take in anticipation of board
- 21 approval under Section 842.001; and
- 22 (3) the powers and duties of a participating
- 23 subdivision to adopt orders or resolutions, make elections, and
- 24 otherwise exercise decision-making authority concerning the rights
- 25 and benefits of the members and annuitants under a plan adopted or
- 26 assumed by the subdivision.
- SECTION 6. Section 842.004, Government Code, is amended to

- 2 Sec. 842.004. GROUP TERM LIFE OPTIONAL PROGRAM [SUPPLEMENTAL DEATH BENEFITS FUND]. 3 (a) Α subdivision participating in the retirement system may elect to participate in 4 5 the optional group term life program [supplemental death benefits 6 fund 1.
- 7 (b) A subdivision that elects to participate in the <u>program</u> 8 [<del>fund</del>] may elect coverage providing postretirement death benefits 9 in addition to coverage providing in-service death benefits.
  - who are members of the retirement system is permitted to participate in the fund, the board of trustees may require the subdivision to provide evidence that is satisfactory to the board that the members are in good health. The board of trustees may allow participation in the fund by those subdivision employees who are in good health on the effective date of participation and exclude those subdivision employees who are not in good health at that time.
  - $[\frac{d}{d}]$  A subdivision that elects to participate in the  $\frac{d}{d}$  program  $[\frac{d}{d}]$  may begin participation on the first day of any month after the month in which the subdivision gives notice of its election to the board of trustees.
  - (d) [(e)] If before November 1 of any year a subdivision gives written notice of its intention to the retirement system, the subdivision may terminate coverage under and discontinue participation in the <a href="mailto:program">program</a> [supplemental death benefits fund]. A termination under this subsection is effective on January 1 of the year following the year in which notice is given.

- 1 (e) [(f)] If a subdivision has previously discontinued 2 participation in the <u>program</u> [fund], the board of trustees in its 3 discretion may restrict the right of the subdivision to participate 4 again.
- 5 SECTION 7. Subchapter A, Chapter 842, Government Code, is 6 amended by adding Section 842.008 to read as follows:

- Subdivision. If a function or activity previously performed by employees of a participating subdivision is transferred to or otherwise taken over by another participating subdivision and any of the employees performing the function or activity transfer to and become employees of the subdivision taking over the function or activity, with the consent of and on terms approved by the board of trustees, the pension liabilities accrued by the transferring employees for service with the transferring subdivision, together with an appropriate portion of trust assets in the account of the transferring subdivision, may be treated as and considered to be a separate account and pension liabilities of the subdivision taking over the function or activity.
- SECTION 8. Section 842.052(d), Government Code, is amended to read as follows:
  - (d) On full performance of the termination agreement, the subdivision is released from all liability for its accrued benefits and supplemental annuities. The retirement system shall make transfers from the subdivision's account to the appropriate funds within the system in amounts actuarially equivalent to the accrued benefits and supplemental annuities. The retirement system shall

- 1 pay any amounts remaining in the subdivision's account after
- 2 satisfaction of all the subdivision's pension liabilities to the
- 3 subdivision or its governmental successor in interest in accordance
- 4 with Section 845.317(b).
- 5 SECTION 9. Sections 842.053(d) and (e), Government Code,
- 6 are amended to read as follows:
- 7 (d) Beginning with a date specified by the board, the 8 retirement system shall value the accrued benefits and supplemental 9 annuities with respect to the subdivision's participation as
- 10 immediately payable under this subchapter. If the assets in the
- 11 subdivision's account exceed the actuarial equivalent value of
- 12 pension benefits, the subdivision is released from all liability
- 13 with respect to the accrued benefits and supplemental annuities.
- 14 The retirement system shall make transfers from the subdivision's
- 15 account to the appropriate funds within the system in amounts
- 16 actuarially equivalent to all accrued benefits and supplemental
- 17 annuities. The retirement system shall pay any amount remaining in
- 18 the subdivision's account after satisfaction of all the
- 19 subdivision's pension liabilities to the subdivision or its
- 20 governmental successor in interest in accordance with Section
- 21 845.317(b).
- (e) If the actuarial equivalent value of pension benefits
- 23 exceeds the assets in the subdivision's account, the subdivision or
- 24 its governmental successor in interest may make a contribution in
- 25 any amount to the subdivision's account. The retirement system
- 26 shall transfer the assets of the subdivision's account in the
- 27 subdivision accumulation fund to appropriate funds within the

- 1 system and allocate the assets as provided by Sections
- 2 842.054-842.057.
- 3 SECTION 10. Section 842.101(b), Government Code, is amended
- 4 to read as follows:
- 5 (b) Except as otherwise provided by this subtitle or by
- 6 rules adopted by the board of trustees, the rights and benefits of a
- 7 member are determined separately with respect to each subdivision
- 8 with which the member has credited service.
- 9 SECTION 11. Section 842.106, Government Code, is amended to
- 10 read as follows:
- 11 Sec. 842.106. MULTIPLE RETIREMENT SYSTEM MEMBERSHIP. [(a)]
- 12 A person who is a member of [an employee eligible for membership and
- 13 eligible to receive credit in] this retirement system [for service
- 14 performed for a participating subdivision is not eligible for
- 15 credit for that service in another public retirement system
- 16 described by Section 801.001 that is at least partly supported by
- 17 the subdivision at public expense. It is the responsibility of the
- 18 subdivision to enforce this provision.
- 19 [(b) A person may simultaneously be a member of this
- 20 retirement system] and another state or local retirement system
- 21 authorized under Section 67, Article XVI, Texas Constitution, [-
- 22 However, a person] may receive a benefit from this system only to
- 23 the extent that the amount of the benefit is computed solely on the
- 24 member's [compensation and] accumulated contributions and service
- 25 credit in this [the] system. Service credited by another
- 26 retirement system may not be used to determine eligibility for a
- 27 benefit in this retirement system except as provided by Chapter

- 1 803.
- 2 SECTION 12. Sections 842.109(a) and (b), Government Code,
- 3 are amended to read as follows:
- 4 (a) A person terminates membership in the retirement system
- 5 by:
- 6 (1) [<del>death;</del>
- 7  $\left[\frac{(2)}{2}\right]$  retirement from all participating subdivisions
- 8 with which the person has service credit; or
- 9 (2)  $[\frac{(3)}{(3)}]$  withdrawal of all of the person's
- 10 accumulated contributions.
- 11 (b) <u>Unless terminated under Subsection (a), a</u> [A] person's
- 12 membership in the retirement system terminates on the earlier of
- 13 the date of the person's death or the last day of the month ending
- 14 before the person's [may not extend beyond the] required beginning
- date determined in accordance with Section 841.010.
- SECTION 13. Section 842.112, Government Code, is amended by
- amending Subsections (e) and (f) and adding Subsections (f-1) and
- 18 (f-2) to read as follows:
- 19 (e) If the act of a third person causes the retirement
- 20 system to make a payment of a survivor benefit or death benefit to
- 21 someone other than the person entitled to the payment, the system
- 22 shall, after receiving credible evidence of an erroneous payment,
- 23 determine the <u>beneficiary</u> [person] entitled to the benefit and, if
- 24 necessary, adjust future payments to the extent practicable to
- 25 ensure that the present value of the remainder of the benefit will
- 26 be paid to the person entitled to it.
- 27 (f) The retirement system is not liable to any person for

- 1 any payments <u>described</u> by <u>Subsection (e)</u> made before the date the
- 2 system receives credible evidence of an erroneous payment. Any
- 3 payments made before that date are a complete discharge of the
- 4 system's responsibility for those payments and benefits.
- 5 (f-1) If, pursuant to a valid application for a withdrawal
- 6 or for retirement, the retirement system issues a check made
- 7 payable to the applicant, properly addressed as directed on the
- 8 application and sent by first-class mail, and the check is
- 9 negotiated by any person, the system is not liable to any person
- 10 with respect to the payment after the first anniversary of the date
- 11 the check was mailed.
- 12 (f-2) If, pursuant to a valid application for a withdrawal
- 13 or for retirement, the retirement system causes funds to be
- 14 electronically transferred to the account specified on the
- application, the system is not liable to any person for that payment
- or any claim relating to the payment beginning on the date of the
- 17 transfer.
- 18 SECTION 14. Subchapter B, Chapter 842, Government Code, is
- amended by adding Section 842.114 to read as follows:
- Sec. 842.114. BURDEN OF PROOF. (a) A person disputing the
- 21 validity of a form, application, or other document filed with the
- 22 retirement system has the burden of proving the document to be
- 23 <u>false, fraudulent, or otherwise invalid.</u>
- 24 (b) A person seeking a correction based on an error caused
- 25 by an act or omission of the retirement system or a subdivision has
- 26 the burden of proving the error and the act or omission causing the
- 27 error.

- 1 (c) A person described by Subsection (a) or (b) has the
- burden of showing:
- 3 (1) reasonableness and diligence in discovering the
- 4 invalidity or error; and
- 5 (2) timeliness in notifying the retirement system or
- 6 the appropriate subdivision.
- 7 SECTION 15. Section 843.001, Government Code, is amended to
- 8 read as follows:
- 9 Sec. 843.001. TYPES OF CREDITABLE SERVICE. The types of
- 10 service creditable as credited service in the retirement system are
- 11 prior service, [and] current service, and optional service.
- 12 SECTION 16. Sections 843.003 and 843.0031, Government Code,
- 13 are amended to read as follows:
- 14 Sec. 843.003. AUTHORIZATION TO REESTABLISH [REESTABLISHING
- 15 CREDITED SERVICE AND SERVICE CREDIT PREVIOUSLY FORFEITED. (a) An
- 16 eligible member who has withdrawn contributions from the retirement
- 17 system may reestablish the forfeited service credit in the system
- if the current service on which the credit was based was performed
- 19 for a participating subdivision the governing body of which by
- order authorizes reestablishment of the credit by eligible employee
- 21 members of the subdivision.
- (b) A member eligible to reestablish service credit under
- 23 this section is one who is a member as an employee of the
- 24 subdivision on the effective date of an order authorized by the
- 25 subdivision under Subsection (a).
- 26 (c) A member eligible under this section may reestablish
- 27 service credit by depositing with the retirement system in a lump

- 1 sum the amount withdrawn from the system, plus a withdrawal charge
- 2 computed at an annual rate of five percent from the date of
- 3 withdrawal to the date of redeposit.
- 4 (d) Prior service credit forfeited because of a withdrawal
- of contributions may not be reestablished under this section [A
- 6 governing body may not make an order under Subsection (a) except on
- 7 the terms provided by Subchapter H, Chapter 844].
- 8 Sec. 843.0031. [ALTERNATIVE] REESTABLISHMENT OF CREDITED
- 9 SERVICE [PREVIOUSLY FORFEITED]; OPTION TO PAY LUMP-SUM AMOUNT. (a)
- 10 A member who has withdrawn contributions from the retirement system
- and who subsequently resumes employment with a subdivision may by
- 12 application to the system at any time before retirement reestablish
- 13 forfeited prior, [and] current, and optional credited service.
- (b) A member who has withdrawn contributions from the
- 15 retirement system and who subsequently resumes employment with a
- 16 subdivision may at any time before retirement pay to the system a
- 17 lump sum in any amount that does not exceed the actuarial present
- value of the additional benefits that would have been attributable
- 19 to the withdrawn contributions. Any amount paid under this
- 20 subsection and interest accrued on the amount may not be considered
- 21 <u>in the computation of service credits.</u>
- 22 (c) With respect to the account with the subdivision for
- 23 which contributions had been withdrawn, after the date an amount is
- 24 deposited under Subsection (b), the member is ineligible to
- 25 reestablish any service credit with the subdivision that had been
- 26 forfeited before the date of redeposit [An amount paid under
- 27 Subsection (b) is not subject to employer matching contributions],

- 1 even if the member would otherwise be eligible under an order
- 2 adopted under Section 843.003.
- 3 SECTION 17. Section 843.102, Government Code, is amended to
- 4 read as follows:
- 5 Sec. 843.102. ELIGIBILITY FOR PRIOR SERVICE CREDIT. (a) A
- 6 [Except as provided by Section 843.108, a] member is eligible to
- 7 receive service credit in the retirement system for prior service
- 8 if the member[+
- 9  $\left[\frac{(1)}{(1)}\right]$  became a member as an employee of a subdivision:
- 10 (1) on the effective date of the subdivision's
- 11 participation in the retirement system; or
- 12 (2) [became a member as an employee of a subdivision]
- 13 before the second [fifth] anniversary of the effective date of its
- 14 participation and continues as an employee of the subdivision for
- 15 at least <u>six months</u> [<u>five consecutive years</u>] after reemployment.
- 16 (b) The board of trustees may adopt rules concerning
- 17 eligibility for prior service credit under Subsection (a).
- 18 (c) A person who has withdrawn contributions from an account
- 19 for service for a subdivision and who subsequently resumes
- 20 employment with the subdivision is not eligible to receive service
- 21 credit under this section for prior service for the subdivision
- 22 [that was not established before the person withdrew the
- 23 contributions].
- SECTION 18. Sections 843.104(a) and (d), Government Code,
- 25 are amended to read as follows:
- 26 (a) A member eligible to receive prior service credit may
- 27 claim the credit by filing a detailed statement of the service with

- 1 the subdivision for which the service was performed. After the
- 2 statement is filed [As soon as practicable after a member files a
- 3 statement of prior service under Section 843.103], the subdivision
- 4 shall [employing the officer receiving the statement shall verify
- 5 the prior service claimed and] certify [to the board of trustees]
- 6 the amount of the member's prior service [approved] and the member's
- 7 average prior service compensation.
- 8 (d) The board of trustees may adopt rules concerning
- 9 [verification and] certification of service and the definition and
- 10 computation of average prior service compensation under this
- 11 section.
- 12 SECTION 19. Section 843.105, Government Code, is amended to
- 13 read as follows:
- 14 Sec. 843.105. DETERMINATION OF MAXIMUM AND ALLOCATED PRIOR
- 15 SERVICE CREDIT. (a) After receiving a certification of prior
- 16 service and average prior service compensation under Section
- 17 843.104, the retirement system shall credit to the member the prior
- 18 <u>service certified and</u> [board of trustees shall] determine the
- 19 member's maximum and allocated prior service credits.
- 20 (b) The maximum prior service credit is an amount equal to
- 21 the accumulation at interest of a series of equal monthly amounts
- 22 for the number of months of certified [approved] prior service.
- 23 Each monthly amount equals twice the subdivision's initial deposit
- 24 rate, times the member's average prior service compensation.
- 25 Interest is allowed at the end of each 12-month period on an
- 26 accumulated amount at the beginning of each period and is credited
- 27 only for each whole 12-month period. The rate of interest allowed

on a maximum prior service credit [granted by a subdivision having

an effective date of participation in the retirement system after

December 31, 1981, is three percent a year.

- (c) Allocated prior service credit is a monetary credit granted by a subdivision to be computed at a member's retirement date and, together with any multiple matching credit, used in determining a member's supplemental annuity. The allocated prior service credit of a member is an amount equal to a percentage of the maximum prior service credit, increased from the subdivision's effective date of participation to the member's effective date of retirement at the applicable rate of interest provided under this subtitle or prior law for the period [The allocated prior service credit is the percentage of the maximum prior service credit granted by the subdivision to all members who performed prior service for the subdivision].
  - (d) The governing body of a subdivision may adopt a percentage to be used to determine allocated prior service credits.

    The rate may be limited to zero or any multiple of five percent

    [Interest is earned on an allocated prior service credit from the effective date of membership to the effective date of retirement at the applicable rate for the period as provided by Section 845.314].
- SECTION 20. Sections 843.201(a), (b), and (c), Government Code, are amended to read as follows:
- 24 (a) <u>In accordance with rules adopted by the board of</u>
  25 <u>trustees, the</u> [<del>The</del>] governing body of a participating subdivision
  26 by order may authorize the establishment of <u>credited service and</u>
  27 prior service credit in the retirement system for service performed

- 1 in a public hospital, utility, or other public facility or
- 2 governmental function during a time the facility was operated or
- 3 function was performed by a unit of government other than the
- 4 subdivision and before:
- 5 (1) the effective date of the subdivision's
- 6 participation in the retirement system, if the facility was
- 7 acquired or the governmental function was taken over by the
- 8 subdivision before that date; or
- 9 (2) the date of acquisition of the facility or the date
- 10 the governmental function was taken over, if the facility was
- 11 acquired or the governmental function was taken over after the
- 12 effective date of the subdivision's participation in the retirement
- 13 system.
- 14 (b) A member eligible to establish credited service and
- 15 prior service credit under this section after an order under
- 16 Subsection (a) is one who was employed by a public facility or by an
- 17 entity performing the governmental function:
- 18 (1) on the effective date of subdivision
- 19 participation, for service under Subsection (a)(1); or
- 20 (2) on the date of acquisition of the facility or the
- 21 date the governmental function was taken over, for service under
- 22 Subsection (a)(2).
- 23 (c) The allocated prior service credit percentage allowable
- under this section may be limited by the order of the governing body
- 25 to zero or to any percentage that is a multiple of five percent [and
- 26 that does not exceed the percentage applicable to the computation
- 27 of allocated prior service credits for employees of other

- 1 departments of the subdivision].
- 2 SECTION 21. Section 843.401, Government Code, is amended to
- 3 read as follows:
- 4 Sec. 843.401. CURRENT SERVICE GENERALLY. Current service
- 5 is service performed by an employee of a participating subdivision
- 6 while a member of the retirement system and credited as provided
- 7 under this section. The retirement system shall credit a member
- 8 with [grant] one month of current service for each month for which
- 9 the required contributions are made, reported, and certified by the
- 10 employing subdivision.
- 11 SECTION 22. Subchapter E, Chapter 843, Government Code, is
- amended by adding Section 843.402 to read as follows:
- 13 Sec. 843.402. CURRENT SERVICE CREDIT AND MULTIPLE MATCHING
- 14 CREDIT. (a) Current service credit is a monetary amount credited
- by a subdivision to be computed at a member's effective retirement
- 16 date and used in determining the member's basic annuity. At the
- 17 determination date, a member's current service credit is an amount
- 18 equal to the sum of the employee contributions in the member's
- 19 individual account and the interest accumulated on those
- 20 contributions as provided by this subtitle.
- 21 (b) Multiple matching credit is a monetary amount credited
- by the governing body of a subdivision to be computed at a member's
- 23 <u>effective retirement date and, together with any prior service</u>
- 24 credit, used in determining a member's supplemental annuity.
- 25 Multiple matching credit is an amount equal to a percentage of the
- sum of employee contributions in a member's individual account that
- 27 were made for a particular calendar year and the interest

- 1 accumulated on those contributions as provided under this subtitle.
- 2 At the determination date, the multiple matching credit of a member
- 3 is equal to the sum of the multiple matching credit for all years of
- 4 the person's membership.
- 5 (c) The percentage to be used in the computation of the
- 6 multiple matching credit for a particular year is adopted by the
- 7 governing body of a subdivision and applied in accordance with this
- 8 subtitle.
- 9 SECTION 23. The heading to Subchapter F, Chapter 843,
- 10 Government Code, is amended to read as follows:
- 11 SUBCHAPTER F. OPTIONAL CREDITED [CURRENT] SERVICE [FOR LEGISLATIVE
- 12 SERVICE]
- SECTION 24. Section 843.501, Government Code, is amended to
- 14 read as follows:
- 15 Sec. 843.501. <u>CREDITED SERVICE FOR</u> LEGISLATIVE SERVICE.
- 16 [<del>(a)</del>] A member may establish credited service in the retirement
- 17 system for service performed as a member of the legislature. A
- 18 member claiming credited service for previous legislative service
- 19 shall file with the retirement system a detailed statement of the

The order awarding the retirement benefit may be set forth in the divorce decree or in an order approving the terms of a property settlement agreement incident to the divorce of the retiree and beneficiary but must be dated on or after December 31, 1999. - Sec. 845.506. APPEAL OF ADMINISTRATIVE DECISION. (a) A decision of the retirement system is final and conclusive unless an appeal is filed in writing with the system by regular mail or electronic filing, as that term is defined by Section 845.116(a)(1), not later than the 90th day after the earlier of the date the person subject to the decision receives notice of the decision by any means or the date the system files notice of its decision with the person by regular mail or electronic means.
- (b) A person may appeal a decision to the board of trustees if the person is aggrieved by a decision of the retirement system relating to the system or any program administered by the system under this subtitle:
- 23 (1) denying or limiting membership, service credit, or eligibility for or the amount of benefits payable by the system; or

SECTION 95. Sections 844.102(a)(1) and (3), Government Code, as amended by this Act, do not apply to a participating subdivision in the Texas County and District Retirement System that on December 31, 2007, required 12 years of credited service before service retirement from the system at age 60 or older. The 12-year credited service requirement to meet the minimum eligibility for service retirement at age 60 or older remains in effect for a subdivision described by this section. A subdivision described by this section subsequently may elect to be subject to Section 844.102, Government Code, as amended by this Act, effective on the date the election is made. 

SECTION 96. A member of the Texas County and District Retirement System who on December 31, 1999, had any eligible credited service with a subdivision that as of that date authorized a service retirement annuity for a member when the sum of the member's age and credited service equaled or exceeded a specified number, whose membership in the retirement system continued after that date without interruption, who has accumulated at least four years of eligible credited service, and whose membership is terminated under Section 842.108(b), Government Code, because of the requirements of Section 841.010, Government Code, is immediately eligible to retire and receive a service retirement annuity computed without actuarial reduction because of the failure to satisfy a required service eligibility provision in effect for the subdivision on the date the annuity is computed.

SECTION 97. Effective September 1, 2007, a participating 1 subdivision in the Texas County and District Retirement System that 2 elected before January 1, 1978, to provide a ratio of current 3 4 service credits to member contributions that is greater than 5 one-to-one, resulting in the larger portion of a member's total 6 service credits consisting of current service credits, may by order 7 of its governing body adopted before January 1, 2008, continue the 8 ratio of current service credits in effect on December 31, 2007, and 9 be exempt from the change in law made to Section 843.003, Government Code, by this Act. The total service credits accumulated by a 10 member may not be reduced as the result of an action or lack of an 11 action taken under this section. 12
