5	SECTION 1. Subchapter B, Chapter 425, Insurance Code, is
6	amended by adding Section 425.071 to read as follows:
7	Sec. 425.071. LAPSE RATES IN MINIMUM STANDARD OF VALUATION.
8	(a) The minimum standard of valuation under this subchapter may
9	include lapse rates in the calculation of reserves for a secondary
10	guarantee in universal life contracts issued after December 31,
11	2006.
12	(b) For purposes of this section, a secondary guarantee
13	refers to specified conditions in a universal life contract that,
14	if satisfied, provide for death benefits to remain in effect
15	regardless of the accumulation value in the contract.
16	(c) Lapse rates authorized by this section may not exceed
17	two percent per year.
18	(d) The commissioner is authorized to adopt rules to
19	implement this section.
20	SECTION 2. This Act takes effect June 1, 2007, if it
21	receives a vote of two-thirds of all the members elected to each
22	house, as provided by Section 39, Article III, Texas Constitution.
23	If this Act does not receive the votes necessary for effect on that
24	date, this Act takes effect September 1, 2007.
