9	authorizing the adoption of a human embryo is required for the
10	transfer of a human embryo to another person for implantation in any
11	person who is not the genetic parent of the embryo or the spouse of a
12	genetic parent.
13	(b) The court may grant the petition of a person residing in
14	this state to adopt an embryo according to this subchapter.
15	Sec. 162.702. JURISDICTION; REQUIREMENTS OF PETITION. (a)
16	The petitioner shall file a suit to adopt an embryo in a court in the
17	county of the petitioner's residence.
18	(b) A petition to adopt an embryo shall be entitled "In the
19	Interest of the Embryo of"
20	(c) If the petitioner is married, both spouses must join in
21	the petition for adoption.
22	Sec. 162.703. CONSENT; COMPENSATION. (a) A court may not
23	grant an adoption of an embryo unless both the man and the woman who
24	contracted for the creation of the embryo have relinquished their

1	parental rights or consented in writing to the adoption by the
2	petitioner and waived any interest in the human embryo.
3	(b) Compensation may not be paid or received to relinquish
4	or waive a person's parental rights with regard to an embryo except
5	for reimbursement for reasonable fees incurred to preserve or
6	transport the embryo.
7	Sec. 162.704. ADOPTION ORDER. The court may grant the
8	adoption if the court finds that the requirements for adoption of an
9	embryo are met and the court finds that the adoption is in the best
10	interest of the embryo.
11	Sec. 162.705. HUMAN EMBRYO TRAFFICKING PROHIBITED;
12	PENALTIES. (a) In this section:
13	(1) "Gamete" means a human sperm or unfertilized human
14	<u>ovum.</u>
15	(2) "Human embryo" means a genetically complete living
16	organism of the species Homo sapien, from the single-cell zygote
17	stage to eight weeks' development.
18	(3) "Human embryo trafficking" means creating a human
19	embryo using in vitro fertilization for the purpose of selling,
20	buying, or transferring for valuable consideration the human embryo
21	to a person who is not a genetic parent of the embryo or the spouse
22	of a genetic parent. The term does not include the adoption of a
23	human embryo or the reimbursement of direct expenses related to the
24	adoption of a human embryo.
25	(b) A person commits an offense if the person knowingly or
26	intentionally:
27	(1) participates in human embryo trafficking;

1	(2) buys, sells, receives, or otherwise transfers a
2	human embryo for valuable consideration, except for lawful
3	reimbursements for embryo adoption as provided for in Section
4	<u>162.703; or</u>
5	(3) buys, sells, receives, or otherwise transfers
6	human gametes for the purpose of human embryo trafficking.
7	(c) An offense under this section is a Class A misdemeanor.
8	SECTION 2. This Act takes effect September 1, 2007.
