H.B. No. 1709

A BILL TO BE ENTITLED

AN ACT

relating to bonds required of guardians and other personal representatives.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

SECTION 1. Sections 205 and 206, Texas Probate Code, are amended to read as follows:

Sec. 205. JUDGE TO REQUIRE NEW BOND. When it shall be known to him that any such bond is in any respect insufficient or that it has, together with the record thereof, been lost or destroyed, the judge shall:

(1) without delay and without notice enter an order requiring the representative to give a new bond; or

(2) without delay cause the representative to be cited to show cause why he should not give a new bond.

Sec. 206. ORDER REQUIRING NEW BOND. (a) The order entered under Section 205(1) of this code must state the reasons for requiring a new bond, the amount of the new bond, and the time within which the new bond must be given, which may not be later than the 10th day after the date of the order.

(b) Upon the return of a citation ordering a personal representative to show cause why he should not give a new bond, the judge shall, on the day named therein for the hearing of the matter, proceed to inquire into the sufficiency of the reasons for requiring a new bond; and, if satisfied that a new bond should be

1 required, he shall enter an order to that effect, stating in such
2 order the amount of such new bond, and the time within which it
3 shall be given, which shall not be later than twenty days from the
4 date of such order.

5 SECTION 2. Sections 713 and 714, Texas Probate Code, are
6 amended to read as follows:

7 Sec. 713. JUDGE TO REQUIRE NEW BOND. When it is made known
8 to a judge that a bond is insufficient or that the bond has, with the
9 record of the bond, been lost or destroyed, the judge [~~without~~
10 ~~delay~~] shall:

11 (1) without delay and without notice enter an order
12 requiring the guardian to give a new bond; or

13 (2) without delay cause the guardian to be cited to
14 show cause why the guardian should not give a new bond.

15 Sec. 714. ORDER REQUIRING NEW BOND. (a) The order entered
16 under Section 713(1) of this code must state the reasons for
17 requiring a new bond, the amount of the new bond, and the time
18 within which the new bond must be given, which may not be later than
19 the 10th day after the date of the order.

20 (b) On the return of a citation ordering a guardian to show
21 cause why the guardian should not give a new bond, the judge on the
22 day contained in the return of citation as the day for the hearing
23 of the matter, shall proceed to inquire into the sufficiency of the
24 reasons for requiring a new bond. If the judge is satisfied that a
25 new bond should be required, the judge shall enter an order to that
26 effect that states the amount of the new bond and the time within
27 which the new bond shall be given, which may not be later than 20

3 SECTION 3. This Act takes effect September 1, 2007.
