Sections 826.0211(a) and (b), Health and Safety Code, are amended to read as follows: 6 7 (a) Information contained in a rabies vaccination certificate or in any record compiled from the information 8 contained in one or more certificates that identifies or tends to 9 identify an owner or an address, telephone number, or other 10 11 personally identifying information of an owner of a vaccinated 12 animal is confidential and not subject to disclosure under Chapter 13 552, Government Code. The information contained in the certificate or record may not include the social security number or the driver's 14 license number of the owner of the vaccinated animal. 15 16 (b) The information may be disclosed only to a governmental entity or a person that, under a contract with a governmental 17 18 entity, provides animal control services or animal registration services for the governmental entity for purposes related to the 19 protection of public health and safety. A governmental entity or 20 21 person that receives the information, including a county or 22 municipality that registers dogs and cats under Subchapter D, must

23 maintain the confidentiality of the information, may not disclose 24 the information under Chapter 552, Government Code, and may not use

1 the information for a purpose that does not directly relate to the 2 protection of public health and safety.

3 SECTION 2. Sections 826.0311(a) and (b), Health and Safety
4 Code, are amended to read as follows:

5 Information that is contained in a municipal or county (a) 6 registry of dogs and cats under Section 826.031 that identifies or 7 tends to identify the owner or an address, telephone number, or 8 other personally identifying information of the owner of the registered dog or cat is confidential and not subject to disclosure 9 under Chapter 552, Government Code. The information contained in 10 the registry may not include the social security number or the 11 12 driver's license number of the owner of the registered animal.

The information may be disclosed only to a governmental 13 (b) entity or a person that, under a contract with a governmental 14 15 entity, provides animal control services or animal registration services for the governmental entity for purposes related to the 16 17 protection of public health and safety. A governmental entity or that receives the information must maintain 18 person the information, 19 confidentiality of the may not disclose the information under Chapter 552, Government Code, and may not use the 20 21 information for a purpose that does not directly relate to the protection of public health and safety. 22

SECTION 3. The change in law made by this Act to Sections 826.0211(a) and 826.0311(a), Health and Safety Code, applies only to a certificate or registration issued, or record compiled, on or after the effective date of this Act.
