1 yield data necessary for research and medical cost containment 2 efforts.

3 The commissioner by rule shall establish reporting (C) 4 requirements for insurance companies regarding workers' compensation claims [may allow the information required by 5 6 Subsection (a) to be reported in the aggregate for each risk for claims in which benefit payments are less than \$5,000]. The 7 commissioner may reduce or eliminate reporting requirements for 8 9 insurance companies whose workers' compensation insurance business falls below a specific minimum premium volume established by the 10 commissioner by rule [adjust the \$5,000 threshold for aggregate 11 reporting to account for inflationary changes]. 12

SECTION 2. To the extent of any conflict, this Act prevails over another Act of the 80th Legislature, Regular Session, 2007, relating to nonsubstantive additions to and corrections in enacted codes.
