INFORMAL COMPLAINT PROCESS REGARDING LOSS OF OR INABILITY TO ACCOUNT FOR NATURAL GAS GATHERED OR TRANSPORTED. 9 (a) A producer may submit a written request to a person who gathers 10 11 or transports gas for the producer for an explanation of any loss of 12 or inability to account for the gas tendered to the person by the producer. The request may ask the person to provide any or all of 13 14 the information that would be required to be included in an accounting under Subsection (c). Not later than the 30th day after 15 16 the date the person receives the request from the producer, the person must provide the producer a written explanation of any loss 17 18 of or inability to account for the gas tendered to the person by the producer. The response must include any relevant information 19 requested by the producer that is available to the person and that 20 21 would be required to be included in an accounting under Subsection 22 (c). 23 (b) If a producer submits a request under Subsection (a) to 24 a person who gathers or transports gas for the producer and the

- person provides an inadequate explanation of any loss of or 1 2 inability to account for the gas, or fails to provide any explanation of any loss of or inability to account for the gas by 3 4 the deadline provided by that subsection, the producer may file with the commission an informal complaint against the person. An 5 6 informal complaint may not be filed before the 30th day after the 7 end of the production period covered by the complaint. An informal 8 complaint must:
- 9 <u>(1) specify the production period covered by the</u> 10 complaint;
- 11 (2) state that at least 30 days have elapsed since the 12 end of the production period covered by the complaint; and
- 13 (3) if the producer metered the volume of gas tendered 14 to the person who gathered or transported the gas:
- 15 (A) describe the type of meter used; and
- 16 (B) state the date the meter was last calibrated.

(c) Not later than the 14th day after the date the complaint

- is filed, the person who gathered or transported the gas shall
  provide to the producer and the commission an accounting of the gas
  tendered to the person by the producer for gathering or transport
  during the production period covered by the complaint. The
- 22 accounting may be provided on a thousand cubic feet or a million
- 23 British thermal unit basis, as applicable, and must include the
- 24 <u>information the commission determines to be necessary to resolve an</u>
- 25 informal complaint under this section, which may include:
- (1) the amount of gas tendered by the producer from
- 27 each well that has a meter;

1	(2) a laboratory analysis of the composition and		
2	heating value of the gas and other substances tendered by the		
3	producer, if such an analysis has been performed;		
4	(3) if available, a schematic drawing of the person's		
5	system for gathering or transporting gas that shows:		
6	(A) each meter type;		
7	(B) the date each meter was last calibrated;		
8	(C) the accuracy of each meter; and		
9	(D) all equipment that alters, disposes of, or		
10	otherwise consumes any of the gas tendered to the person;		
11	(4) the estimated amount of gas used for fuel, flared,		
12	or vented for construction, repair, maintenance, or other		
13	operational uses and, if the information is available, the location		
14	of that use;		
15	(5) the estimated amount of contaminants or other		
16	impurities removed from the gas and the location at which the		
17	<pre>impurities were removed;</pre>		
18	(6) the estimated amount of liquid hydrocarbons and		
19	condensate removed from the gas and the location at which the liquid		
20	hydrocarbons and condensate were removed;		
21	(7) the estimated amount of gas lost and the location		
22	at which the gas was lost;		
23	(8) the estimated amount of gas redelivered by the		
24	person, including the amount of gas sold that was allocated to the		
25	producer, and the location at which the redelivery of the gas		
26	occurred;		
27	(9) any amount of gas received from the producer by the		

- 1 person that remains unaccounted for; and
- 2 (10) any other information the person who gathered or
- 3 transported the gas considers relevant to the resolution of the
- 4 complaint.
- 5 (d) The commission may grant an extension of time to the
- 6 person who gathered or transported the gas to provide the
- 7 accounting required by Subsection (c). An extension may not permit
- 8 the accounting to be provided later than the 45th day after the date
- 9 the informal complaint was filed.
- (e) If the person who gathered or transported the gas does
- 11 not have the information necessary to provide the accounting
- required by Subsection (c), the person must provide to the producer
- and to the commission a written explanation of the reason the person
- 14 does not have the information.
- (f) If the person who gathered or transported the gas fails
- 16 to provide the accounting required by Subsection (c) or the
- 17 explanation required by Subsection (e), the informal complaint
- 18 filed by the producer is considered to be valid.
- 19 (g) If Subsection (f) applies or the commission determines
- 20 that the person who gathered or transported the gas committed
- 21 waste, the commission may take any action it considers appropriate,
- 22 <u>including issuing an order in a formal proceeding to prevent waste</u>
- 23 by the person who gathered or transported the gas.
- 24 (h) This subsection applies only to a producer and a person
- 25 who gathers or transports gas for the producer under a contract
- between the producer and that person that is entered into or renewed
- 27 on or after September 1, 2007. On written request, the producer is

entitled to audit the books and records of the person that pertain to the contract between the producer and the person for the purpose of verifying whether any gas tendered to the person by the producer that the person has lost or is unable to account for has been allocated to the volume of gas tendered to the person by the producer as required by the contract. A producer is not entitled to conduct an audit under this subsection more frequently than annually.

SECTION 2. Section 85.065, Natural Resources Code, as added by this Act, applies only to the loss of or inability to account for natural gas that is tendered by a producer to a gatherer or transporter of gas on or after the effective date of this Act. The loss of or inability to account for natural gas that is tendered by a producer to a gatherer or transporter of gas before the effective date of this Act is governed by the law in effect on the date the gas is tendered, and the former law remains in effect for that purpose.

17 SECTION 3. This Act takes effect September 1, 2007.
