A BILL TO BE ENTITLED 1 AN ACT 2 relating to the authority to impose a county hotel occupancy tax. 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: 4 SECTION 1. Section 352.002(a), Tax Code, is amended to read 5 as follows: The commissioners courts of the following counties by 6 (a) 7 the adoption of an order or resolution may impose a tax on a person who, under a lease, concession, permit, right of access, license, 8 contract, or agreement, pays for the use or possession or for the 9 right to the use or possession of a room that is in a hotel, costs \$2 10 11 or more each day, and is ordinarily used for sleeping: 12 (1) a county that has a population of more than 3.3 13 million; 14 (2) a county that has a population of 90,000 or more, borders the United Mexican States, and does not have three or more 15 cities that each have a population of more than 17,500; 16 (3) a county in which there is no municipality; 17 a county in which there is located an Indian 18 (4) reservation under the jurisdiction of the United States government; 19 (5) a county that has a population of 30,000 or less, 20 21 that has no more than one municipality with a population of less 22 than 2,500, and that borders two counties located wholly in the Edwards Aquifer Authority established by Chapter 626, Acts of the 23 24 73rd Legislature, Regular Session, 1993;

No. 2058 1 (6) a county that borders the Gulf of Mexico; 2 (7) a county that has a population of less than 5,000, that borders the United Mexican States, and in which there is 3 4 located a major observatory; 5 (8) a county that has a population of 12,000 or less 6 and borders the Toledo Bend Reservoir; 7 (9) a county that has a population of less than 12,000 8 and an area of less than 275 square miles; a county that has a population of 30,000 or less 9 (10)10 and borders Possum Kingdom Lake; a county that borders the United Mexican States 11 (11)and has a population of more than 300,000 and less than 600,000; 12 a county that has a population of 35,000 or more 13 (12) 14 and borders or contains a portion of Lake Fork Reservoir; 15 (13) a county that borders the United Mexican States and in which there is located a national recreation area; 16 17 (14) a county that borders the United Mexican States and in which there is located a national park of more than 400,000 18 19 acres; a county that has a population of 28,000 or less, 20 (15) 21 that has no more than four municipalities, and that is located wholly in the Edwards Aquifer Authority established by Chapter 626, 22 Acts of the 73rd Legislature, Regular Session, 1993; 23 24 (16) a county that has a population of 25,000 or less, 25 whose territory is less than 750 square miles, and that has two 26 incorporated municipalities, each with a population of 800 or less, 27 located on the Frio River;

1 (17) a county that has a population of 34,000 or more 2 and borders Lake Buchanan; 3 (18) a county that has a population of more than 45,000 4 and less than 75,000, that borders the United Mexican States, and 5 that borders or contains a portion of Falcon Lake; 6 (19) a county with a population of 21,000 or less that borders the Neches River and in which there is located a national 7 8 preserve; (20) a county that has a population of 22,500 or less 9 and that borders or contains a portion of Lake Livingston; [and] 10 a county that has a population of less than 22,000 11 (21)and in which the birthplace of a president of the United States is 12 located; and 13 (22) a county that has a population of less than 9,000 14 15 and through which the Bosque, Leon, and Lampasas Rivers run. SECTION 2. This Act takes effect immediately if it receives 16 17 a vote of two-thirds of all the members elected to each house, as provided by Section 39, Article III, Texas Constitution. If this 18 Act does not receive the vote necessary for immediate effect, this 19 Act takes effect September 1, 2007. 20
