1 AN ACT

- 2 relating to additional criminal law magistrates in Bexar County.
- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 4 SECTION 1. Subchapter N, Chapter 54, Government Code, is
- 5 amended by adding Section 54.900 to read as follows:
- 6 Sec. 54.900. APPLICABILITY OF SUBCHAPTER. The provisions
- 7 of this subchapter apply only to a criminal law magistrate in Bexar
- 8 County who is appointed under this subchapter.
- 9 SECTION 2. Chapter 54, Government Code, is amended by adding Subchapter AA to read as follows:
- 11 SUBCHAPTER AA. ADDITIONAL CRIMINAL LAW MAGISTRATES IN BEXAR COUNTY
- Sec. 54.1301. APPLICABILITY OF SUBCHAPTER. The provisions
- of this subchapter apply only to a criminal law magistrate in Bexar
- 14 County who is appointed under this subchapter.
- 15 Sec. 54.1302. APPOINTMENT; PRESIDING MAGISTRATE. (a) The
- 16 judges of the district courts of Bexar County that give preference
- 17 to criminal cases and the judges of the county courts at law of
- 18 Bexar County that give preference to criminal cases, with the
- 19 consent and approval of the Commissioners Court of Bexar County,
- 20 <u>may:</u>
- (1) appoint the number of magistrates set by the
- 22 <u>commissioners court to perform the duties authorized by this</u>
- 23 subchapter; and
- 24 (2) select one magistrate appointed under Subdivision

- 1 (1) to serve as the presiding magistrate to supervise the other
- 2 magistrates appointed under that subdivision.
- 3 (b) Each magistrate's appointment, as well as the selection
- 4 of the presiding magistrate, must be made with the approval of
- 5 two-thirds of the judges described by Subsection (a).
- 6 (c) The term of appointment of a magistrate under this
- 7 section may not exceed two years, subject to Section 54.1307.
- 8 <u>(d) If the number of magistrates appointed under this</u>
- 9 section is less than the number of the appointing judges, each judge
- described by Subsection (a) shall have equal access to the services
- of the magistrates appointed under this section.
- 12 Sec. 54.1303. QUALIFICATIONS. To be eligible for
- 13 appointment as a magistrate under this subchapter, a person must:
- 14 (1) be a resident of Bexar County; and
- 15 (2) have been licensed to practice law in this state
- 16 for at least four years.
- Sec. 54.1304. COMPENSATION. (a) A magistrate appointed
- 18 under this subchapter is entitled to the salary determined by the
- 19 Commissioners Court of Bexar County.
- 20 (b) The magistrate's salary is paid from the county fund
- 21 available for payment of officers' salaries.
- 22 Sec. 54.1305. JUDICIAL IMMUNITY. A magistrate appointed
- 23 under this subchapter has the same judicial immunity as a district
- 24 judge.
- Sec. 54.1306. CLERK. (a) The district clerk shall perform
- 26 the statutory duties described by Section 51.303 with respect to
- 27 all cases and matters referred to the magistrates appointed under

- 2 and, if authorized under Section 54.1309, municipal courts, subject
- 3 to Subsection (b).
- 4 (b) At the conclusion of a proceeding, the district clerk
- 5 shall transmit to the referring court any papers relating to the
- 6 case or matter referred to a magistrate appointed under this
- 7 subchapter, including the magistrate's findings, conclusions,
- 8 orders, recommendations, or other action taken, except when the
- 9 magistrate is performing the duties of a magistrate under the Code
- 10 of Criminal Procedure.
- 11 Sec. 54.1307. TERMINATION OF SERVICES. The services of a
- 12 magistrate appointed under this subchapter may be terminated by a
- 13 majority vote of the appointing judges.
- Sec. 54.1308. PROCEEDINGS THAT MAY BE REFERRED. (a) Except
- 15 as provided by Subsection (b), a judge described by Section
- 16 <u>54.1302(a) may refer to a magistrate appointed under this</u>
- 17 subchapter any criminal cases or matters the judge considers
- 18 necessary and proper, including a criminal case for drug court
- 19 proceedings.
- 20 (b) A magistrate appointed under this subchapter may not
- 21 preside over a contested trial on the merits, regardless of whether
- 22 the trial is before a jury.
- Sec. 54.1309. CERTAIN MUNICIPAL COURT PROCEEDINGS THAT MAY
- 24 BE REFERRED. (a) A municipality that has any portion of the
- 25 municipality's territory located within the boundaries of Bexar
- 26 County may:
- 27 (1) enter into an interlocal agreement with Bexar

- 1 County providing for the referral of cases from the municipal
- 2 courts of that municipality to a magistrate appointed under this
- 3 <u>subchapter; and</u>
- 4 (2) by ordinance, authorize one or more municipal
- 5 court judges to refer cases pending in the municipal courts to a
- 6 magistrate appointed under this subchapter.
- 7 (b) A municipal court judge who is authorized to refer a
- 8 case to a magistrate as provided by Subsection (a) may refer one or
- 9 more cases to a magistrate in the manner provided by Section
- 10 54.1310. The magistrate to whom the case is referred may exercise
- any power conferred on the magistrate under Section 54.1311, except
- 12 as limited by the order of referral.
- Sec. 54.1310. ORDER OF REFERRAL. (a) To refer one or more
- 14 criminal cases or matters to a magistrate appointed under this
- subchapter, a judge must issue an order of referral specifying the
- 16 magistrate's duties.
- 17 (b) An order of referral may relate to a single case or to a
- 18 specified type of criminal cases or matters.
- 19 (c) An order of referral may:
- 20 (1) limit the powers of the magistrate and direct the
- 21 magistrate to report on specific issues, perform particular acts,
- 22 <u>or receive and report on evidence only;</u>
- 23 (2) set the time and place for the hearing;
- 24 (3) prescribe a closing date for the hearing;
- 25 (4) provide a date for filing the magistrate's
- 26 findings;
- 27 (5) designate proceedings for more than one case over

2	(6) direct the magistrate to call the court's docket;
3	<u>and</u>
4	(7) set forth general powers and limitations of
5	authority of the magistrate applicable to any cases or matters
6	referred.
7	(d) Any magistrate appointed under this subchapter may
8	carry out the duties specified in an order of referral issued under
9	this subchapter.
10	Sec. 54.1311. POWERS. (a) Except as limited by an order of
11	referral, a magistrate appointed under this subchapter may:
12	(1) perform the duties of a magistrate under the Code
13	of Criminal Procedure;
14	(2) conduct hearings;
15	(3) hear evidence;
16	(4) compel production of relevant evidence;
17	(5) rule on admissibility of evidence;
18	(6) issue summons for the appearance of witnesses;
19	(7) examine witnesses;
20	(8) swear witnesses for hearings;
21	(9) make findings of fact on evidence;
22	(10) formulate conclusions of law;
23	(11) rule on preliminary motions;
24	(12) recommend the rulings, orders, or judgment to be
25	<pre>made in a case;</pre>
26	(13) regulate proceedings in a hearing;
27	(14) set bonds;

- 1 (15) in any case referred under Section 54.1310,
- 2 accept an agreed plea of guilty or nolo contendere or an agreed plea
- 3 <u>bargain recommendation;</u>
- 4 (16) in any case referred under Section 54.1310 that
- 5 is not a felony case:
- 6 (A) accept an agreed recommendation for a
- 7 presentence investigation report in which a plea will be accepted
- 8 by the magistrate and the sentence will be determined by the judge
- 9 of the referring court;
- 10 (B) enter a finding of guilt, impose or suspend a
- 11 sentence under an agreed plea bargain recommendation, and establish
- 12 conditions of community supervision; or
- (C) defer adjudication of guilt under an agreed
- 14 plea bargain recommendation and establish conditions of community
- 15 supervision; and
- 16 (17) perform any act and take any measure necessary
- and proper for the efficient performance of the duties required by
- 18 the order of referral.
- 19 (b) Except when performing the duties of a magistrate under
- 20 the Code of Criminal Procedure, a magistrate appointed under this
- 21 subchapter may not enter a ruling on any issue of law or fact if that
- 22 ruling could result in dismissal or require dismissal of a pending
- 23 criminal prosecution, but the magistrate may make findings,
- 24 conclusions, and recommendations on those issues, subject to
- 25 Section 54.1314.
- Sec. 54.1312. COURT REPORTER. The court shall provide a
- 27 court reporter to record the proceedings before a magistrate

- 1 appointed under this subchapter if:
- 2 (1) the appointment of a court reporter is required by
- 3 other law; or
- 4 (2) a party to a case involving an offense that is a
- 5 Class B misdemeanor or higher category of offense requests the
- 6 appointment of a court reporter, unless the magistrate appointed
- 7 under this subchapter is performing the duties of a magistrate
- 8 under the Code of Criminal Procedure.
- 9 Sec. 54.1313. WITNESS. (a) A witness who appears before a
- 10 magistrate appointed under this subchapter and is sworn is subject
- to the penalties for perjury provided by law.
- 12 (b) A referring court may issue attachment against and may
- 13 fine or imprison a witness whose failure to appear after being
- summoned or whose refusal to answer questions has been certified to
- 15 the court.
- Sec. 54.1314. JUDICIAL ACTION. (a) Unless otherwise
- 17 prohibited by law and except when a magistrate appointed under this
- 18 subchapter is performing the duties of a magistrate under the Code
- 19 of Criminal Procedure, a referring court may modify, correct,
- 20 reject, reverse, or recommit for further information any action
- 21 taken by the magistrate.
- (b) If the court does not modify, correct, reject, reverse,
- or recommit an action of the magistrate, the action becomes the
- 24 decree of the court.
- 25 SECTION 3. Article 2.09, Code of Criminal Procedure, is
- 26 amended to read as follows:
- 27 Art. 2.09. WHO ARE MAGISTRATES. Each of the following

1 officers is a magistrate within the meaning of this Code: 2 justices of the Supreme Court, the judges of the Court of Criminal 3 Appeals, the justices of the Courts of Appeals, the judges of the 4 District Court, the magistrates appointed by the judges of the 5 district courts of Bexar County, Dallas County, or Tarrant County 6 that give preference to criminal cases, the criminal law hearing 7 officers for Harris County appointed under Subchapter L, Chapter 8 54, Government Code, the criminal law hearing officers for Cameron 9 County appointed under Subchapter BB, Chapter 54, Government Code, 10 the magistrates appointed by the judges of the district courts of Lubbock County, Nolan County, or Webb County, the magistrates 11 appointed by the judges of the criminal district courts of Dallas 12 County or Tarrant County, the masters appointed by the judges of the 13 14 district courts and the county courts at law that give preference to criminal cases in Jefferson County, the magistrates appointed by 15 the judges of the district courts and the statutory county courts of 16 17 Brazos County or Williamson County, the magistrates appointed by the judges of the district courts and statutory county courts that 18 19 give preference to criminal cases in Travis County or Bexar County, the county judges, the judges of the county courts at law, judges of 20 21 the county criminal courts, the judges of statutory probate courts, the associate judges appointed by the judges of the statutory 22 probate courts under Subchapter G, Chapter 54, Government Code, the 23 24 justices of the peace, and the mayors and recorders and the judges of the municipal courts of incorporated cities or towns. 25

SECTION 4. This Act takes effect immediately if it receives a vote of two-thirds of all the members elected to each house, as
