6	SECTION 1. Subchapter C, Chapter 552, Government Code, is
7	amended by adding Section 552.148 to read as follows:
8	Sec. 552.148. EXCEPTION: RECORDS OF COMPTROLLER OR
9	APPRAISAL DISTRICT RECEIVED FROM PRIVATE ENTITY. (a) Information
10	relating to real property sales prices, descriptions,
11	characteristics, and other related information received from a
12	private entity by the comptroller or the chief appraiser of an
13	appraisal district under Chapter 6, Tax Code, is excepted from the
14	requirements of Section 552.021.
15	(b) Notwithstanding Subsection (a), the property owner or
16	the owner's agent may, on request, obtain from the chief appraiser
17	of the applicable appraisal district a copy of each item of
18	information described by Section 41.461(a)(2), Tax Code, and a copy
19	of each item of information that the chief appraiser took into
20	consideration but does not plan to introduce at the hearing on the
21	protest. In addition, the property owner or agent may, on request,
22	obtain from the chief appraiser comparable sales data from a
23	reasonable number of sales that is relevant to any matter to be
24	determined by the appraisal review board at the hearing on the

property owner's protest. Information obtained under this 1 2 subsection: 3 (1) remains confidential in the possession of the 4 property owner or agent; and 5 (2) may not be disclosed or used for any purpose except 6 as evidence or argument at the hearing on the protest. (c) Notwithstanding Subsection (a) or Section 403.304, 7 Government Code, so as to assist a property owner, a school 8 9 district, or an appraisal district in a protest filed under Section 403.303, Government Code, the property owner, the district, or an 10 agent of the property owner or district may, on request, obtain from 11 12 the comptroller any information, including confidential information, obtained by the comptroller in connection with the 13 comptroller's finding that is being protested. Confidential 14 15 information obtained by a property owner, a school district, an appraisal district, or an agent of the owner or district under this 16 17 subsection: (1) remains confidential in the possession of the 18 19 owner, district, or agent; and 20 (2) may not be disclosed to a person who is not 21 authorized to receive or inspect the information. SECTION 2. This Act takes effect immediately if it receives 22 a vote of two-thirds of all the members elected to each house, as 23 24 provided by Section 39, Article III, Texas Constitution. If this 25 Act does not receive the vote necessary for immediate effect, this 26 Act takes effect September 1, 2007.
