- 5 SECTION 1. Section 254.037, Election Code, is amended to

- 7 Sec. 254.037. FILING DEADLINE. (a) Except as provided by
- 8 <u>Subsection (b), the [The]</u> deadline for filing a report required by
- 9 this chapter is 5 p.m. on the last day permitted under this chapter
- 10 for filing the report.
- 11 (b) The deadline for filing a report electronically with the
- 12 commission as required by this chapter is midnight on the last day
- 13 for filing the report.
- SECTION 2. Section 254.038(c), Election Code, is amended to
- 15 read as follows:
- 16 (c) A report under this section shall be filed
- 17 electronically, by telegram or telephonic facsimile machine, or by
- 18 hand, in the form required by Section 254.036. The commission must
- 19 receive <u>a</u> [the] report <u>under this section filed by telegram,</u>
- 20 <u>telephonic facsimile machine</u>, or hand not later than 5 p.m. of the
- 21 first business day after the date the contribution is accepted. $\underline{\text{The}}$
- 22 <u>commission must receive a report under this section filed</u>
- 23 electronically not later than midnight of the first business day
- 24 after the date the contribution is accepted. A report under this

- 1 section is not required to be accompanied by the affidavit required
- 2 under Section 254.036(h) or to be submitted on a form prescribed by
- 3 the commission. A report under this section that complies with
- 4 Section 254.036(a) must be accompanied by an affidavit under
- 5 Section 254.036(c)(1) unless the candidate or committee has
- 6 submitted an affidavit under Section 254.036(c)(1) with another
- 7 report filed in connection with the election for which a report is
- 8 required under this section.
- 9 SECTION 3. Section 302.015(b), Government Code, is amended
- 10 to read as follows:
- 11 (b) A statement required to be filed on the day before a
- 12 regular or called session convenes must actually be delivered and
- in the possession of the Texas Ethics Commission not later than
- 14 midnight [5 p.m.] of that day.
- 15 SECTION 4. Section 305.010, Government Code, is amended to
- 16 read as follows:
- 17 Sec. 305.010. TIMELINESS OF FILING REGISTRATIONS AND
- 18 REPORTS. (a) A registration or report filed by first-class United
- 19 States mail or by common or contract carrier is timely if:
- 20 (1) it is properly addressed with postage or handling
- 21 charges prepaid; and
- 22 (2) it bears a post office cancellation mark or a
- 23 receipt mark from a common or contract carrier indicating a time
- 24 within the applicable filing period or before the applicable filing
- 25 deadline or if the person required to file furnishes satisfactory
- 26 proof that it was deposited in the mail or with a common or contract
- 27 carrier within that period or before that deadline.

- 1 (b) A registration or report filed by means of electronic
- 2 transfer is timely if it is received by the commission not later
- 3 than midnight on the last day permitted under this chapter for
- 4 filing the report or registration.
- 5 SECTION 5. Subchapter C, Chapter 571, Government Code, is
- 6 amended by adding Section 571.0645 to read as follows:
- 7 Sec. 571.0645. FILING DEADLINE FOR ELECTRONIC REPORTS. The
- 8 commission shall by rule establish that the deadline for any report
- 9 filed electronically with the commission is midnight on the last
- 10 day for filing the report under the law requiring the filing of the
- 11 report.
- 12 SECTION 6. This Act takes effect September 1, 2007.
