## A BILL TO BE ENTITLED

5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
6	SECTION 1. Subtitle A, Title 14, Occupations Code, is
7	amended by adding Chapter 2308 to read as follows:
8	CHAPTER 2308. AUTOMOTIVE SHOPS, TECHNICIANS, AND AUTOMOTIVE
9	SERVICE WRITERS, ADVISORS, AND ESTIMATORS
10	SUBCHAPTER A. GENERAL PROVISIONS
11	Sec. 2308.001. DEFINITIONS. In this chapter:
12	(1) "Advisory board" means the automobile service and
13	repair advisory board.
14	(2) "Automobile" means a passenger automobile or light
15	truck.
16	(3) "Automobile service and repair" means replacing
17	parts, changing fluids, diagnosing problems, painting, or
18	modifying the frame or body of an automobile.
19	(4) "Automotive service writing, advising, and
20	estimating" means evaluating the services and repairs needed to
21	maintain or repair an automobile, estimating the cost of the
22	services and repairs, and writing an order for the services and
23	repairs.

(5) "Commission" means the Texas Commission of

- 2 (6) "Department" means the Texas Department of
- 3 Licensing and Regulation.
- 4 (7) "Executive director" means the executive director
- 5 of the department.

- 7 <u>SUBCHAPTER B. EXEMPTIONS</u>
- 8 Sec. 2308.051. SERVICE AND REPAIR WITHOUT COMPENSATION.
- 9 This chapter does not apply to a person who performs automobile
- 10 service and repair and who does not receive or expect to receive
- 11 compensation for the person's labor or from the provision of parts
- 12 or materials.
- Sec. 2308.052. EDUCATIONAL FACILITIES. This chapter does
- 14 not apply to a person who performs automobile service and repair at
- an educational facility on automobiles owned by the facility.
- Sec. 2308.053. AUTOMOBILE FLEET OWNERS. This chapter does
- 17 not apply to an automobile fleet owner or to a person who is
- 18 employed by an automobile fleet owner who performs automobile
- 19 service and repair on fleet automobiles.
- Sec. 2308.054. FRANCHISED DEALERS. This chapter does not
- 21 apply to a franchised dealer, as defined by Section 2301.002, or to
- 22 a person employed by a franchised dealer, if the franchised dealer
- 23 performs automobile service and repair only on automobiles
- 24 manufactured or distributed under the dealer's franchise.
- 25 Sec. 2308.055. AGRICULTURAL VEHICLES. This chapter does
- 26 not apply to a person who performs automobile service and repair on
- 27 automobiles used primarily for the production, harvest, or

- transportation of livestock or crops. 1 2 [Sections 2308.056-2308.100 reserved for expansion] 3 SUBCHAPTER C. POWERS AND DUTIES 4 Sec. 2308.101. GENERAL POWERS AND DUTIES. (a) The 5 executive director shall prescribe the design of an original and a 6 renewal license. 7 (b) The commission shall maintain a record of the 8 commission's proceedings under this chapter. (c) The executive director may authorize disbursements 9 necessary to implement this chapter, including disbursements for 10
- 12 <u>(d) The commission by rule shall prescribe the term of a</u>
  13 <u>license or certificate issued under this chapter. A license or</u>
  14 <u>certificate issued under this chapter expires at the end of the</u>
  15 <u>term.</u>

  22 director shall set insurance requirements for automotive shops
  23 licensed under this chapter.
- 24 <u>(b) The executive director may waive the insurance</u>
  25 <u>requirement for an automotive shop that does not engage in</u>
  26 automobile service and repair for the public.

The executive director shall make the information under Section 51.251 3 4 available to the public in the form of a pamphlet to be distributed 5 at each licensed automotive shop. 6 Sec. 2308.152. COMPLAINT INFORMATION. (a) The executive 7 director shall provide to the public information about each 8 unresolved complaint under this chapter. 9 (b) The executive director shall provide to the public a 10 list of licensed automotive shops that have no current unresolved 11 complaints. 12 Sec. 2308.153. CONSUMER INFORMATION HOTLINE. In coordination with the telephone information system under Section 13 14 51.452, the department shall operate a telephone hotline to provide 15 information to consumers about the licensing and complaint procedures under this chapter. 16 17 [Sections 2308.154-2308.200 reserved for expansion] SUBCHAPTER E. AUTOMOBILE SERVICE AND REPAIR ADVISORY BOARD 18 Sec. 2308.201. ADVISORY BOARD MEMBERSHIP. The automobile 19 service and repair advisory board consists of 12 members appointed 20 21 by the commission. Four members of the board are representatives of 22 the public and eight are representatives of the automobile service and repair industry. 23 24 Sec. 2308.202. ADVISORY BOARD DUTIES. (a) The advisory 25 board shall advise the commission in administering and enforcing this chapter. 26

(b) The commission shall give the advisory board the

- 4 Sec. 2308.203. TERMS; VACANCY. (a) Advisory board members
- 5 serve staggered six-year terms. The terms of four elected members
- 6 expire on February 1 of each odd-numbered year.
- 7 (b) If a vacancy occurs during a member's term, the
- 8 presiding officer of the commission, with the commission's
- 9 approval, shall fill the vacancy for the remainder of the unexpired
- 10 term with a person who represents the same interests as the
- 11 predecessor.
- 12 Sec. 2308.204. PRESIDING OFFICER. The members of the
- 13 advisory board shall elect one member to serve as presiding officer
- 14 for a two-year term.
- Sec. 2308.205. COMPENSATION; REIMBURSEMENT. An advisory
- 16 board member serves without compensation but is entitled to
- 17 reimbursement for actual and necessary expenses incurred in
- 18 performing functions as an advisory board member, subject to any
- 19 applicable limitation on reimbursement provided by the General
- 20 Appropriations Act.
- Sec. 2308.206. MEETINGS. (a) The advisory board shall meet
- 22 <u>at least every six months and may meet at</u> other times at the call of
- 23 the presiding officer.
- 24 (b) The advisory board shall meet in this state at a place
- 25 designated by the board.
- Sec. 2308.207. APPLICABILITY OF OTHER LAW. Chapter 2110,
- 27 Government Code, does not apply to the advisory board.

2	SUBCHAPTER F. AUTOMOTIVE SHOP LICENSE REQUIREMENTS
3	Sec. 2308.251. LICENSE REQUIRED. (a) Except as provided by
4	Subsection (b), a person may not operate a business that performs or
5	offers to perform automobile service and repair unless the person
6	holds an automotive shop license issued under this subchapter.
7	(b) A person that submits an application under Section
8	2308.253 may perform automobile service and repair for 90 days
9	after the date the person submits the application. If the executive
10	director denies the initial application for a license under this
11	subchapter, the person may engage in the business of automobile
12	service and repair for 90 days after the date the executive director
13	denies the initial application.
14	Sec. 2308.252. ELIGIBILITY REQUIREMENTS. (a) Each
15	applicant for an automotive shop license must have:
16	(1) a current garagekeeper's insurance policy and a
17	current liability insurance policy in amounts required by
18	<pre>commission rule;</pre>
19	(2) all occupational and business permits required by
20	the state and by each political subdivision having jurisdiction
21	over the shop;
22	(3) a sales tax permit for the shop issued by the
23	<pre>comptroller;</pre>
24	(4) a business checking account for the shop;
25	(5) a licensed automotive technician as an owner or
26	<pre>full-time manager of the shop;</pre>
27	(6) an Employer Identification Number issued by the

2	(7) an invoice form for use in the shop that meets the
3	requirements of this chapter; and
4	(8) an estimate form for use in the shop that meets the
5	requirements of this chapter.
6	(b) In addition to the requirements in Subsection (a), an
7	applicant that will perform collision repairs must have:
8	(1) a paint spray booth that meets applicable air
9	<pre>quality standards;</pre>
10	(2) a frame pulling machine; and
11	(3) a frame dimension measurement system that includes
12	current frame dimension specifications.
13	(c) The commission by rule may adopt additional
14	requirements for an applicant for an automotive shop license.
15	Sec. 2308.253. APPLICATION; FEE. (a) An applicant for an
16	automotive shop license must submit a verified application on a
17	form prescribed by the executive director.
18	(b) The application must be accompanied by:
19	(1) evidence that the applicant meets the eligibility
20	requirements under Section 2308.252;
21	(2) a copy of the certificate of formation, articles
22	of incorporation, assumed name certificate, or other applicable
23	documentation establishing the applicant's business entity; and
24	(3) the application fee.

5	journeyman, or master automotive technician certificate issued
6	under this subchapter.
7	Sec. 2308.302. AUTOMOTIVE TECHNICIAN CERTIFICATE AREAS.
8	(a) The executive director shall issue automotive technician
9	certificates in the following repair areas:
10	(1) engine;
11	(2) automatic transmission and transaxle;

23	rule shall establish eligibility requirements for an automotive
24	technician certificate in each area. The commission may accept a
25	certification issued by a national organization, including the
26	National Institute for Automotive Service Excellence and the
27	Inter-Industry Conference on Auto Collision Repair, as

- 1 satisfaction of all or part of the eligibility requirements for an

- 3 Sec. 2308.304. APPLICATION; FEE. (a) An applicant for an

- 8 Sec. 2308.305. ISSUANCE OF CERTIFICATE. (a) The executive

- 12 two years of continuous, full-time employment related to the area.
- 13 (b) The executive director shall issue a journeyman's
- 14 <u>certificate in an area listed in Section 2308.302(a) to an</u>
- 15 applicant who pays the certification fee, meets the eligibility
- 16 requirements for the area, and has at least two years of continuous,
- 17 full-time employment related to the area.
- 18 (c) The executive director shall issue a master automotive
- 19 technician certificate to an applicant who pays the certification
- 20 fee, has at least five years of continuous, full-time experience in
- 21 <u>automobile service and repair, and meets the requirements for a</u>
- 22 certificate in each of the following repair areas:
- (1) engine;
- 24 (2) automatic transmission and transaxle;
- 25 (3) manual drive train and axles;
- 26 (4) suspension and steering;
- 27 (5) brakes;

1	(6) electrical and electronic systems;
2	(7) heating and air conditioning; and
3	(8) engine performance.
4	(d) The executive director shall issue a master collision
5	repair technician certificate to an applicant who pays the
6	certification fee, has at least five years of continuous, full-time
7	experience in automobile collision repair, and meets additional
8	requirements established by commission rule.
9	Sec. 2308.306. CONTINUING EDUCATION. A certificate holder
10	must complete 30 hours of continuing education each year to renew
11	all certificates the individual holds.
12	[Sections 2308.307-2308.350 reserved for expansion]
13	SUBCHAPTER H. AUTOMOTIVE SERVICE WRITER, ADVISOR, AND ESTIMATOR
14	CERTIFICATION REQUIREMENTS
15	Sec. 2308.351. AUTOMOTIVE SERVICE WRITER, ADVISOR, AND
16	ESTIMATOR CERTIFICATION REQUIRED. (a) Except as provided by
17	Subsection (b), an individual may not provide or offer to provide
18	automotive service writing, advising, and estimating unless the
19	individual holds an automotive service writer, advisor, and
20	estimator certificate issued under this subchapter.
21	(b) This subchapter does not apply to a person employed by
22	an automotive shop that employs fewer than three employees.
23	Sec. 2308.352. ELIGIBILITY REQUIREMENTS. The commission by
24	rule shall establish eligibility requirements for an automotive
25	service writer, advisor, and estimator certificate. The commission
26	may accept a certification issued by a national organization,
27	including the National Institute for Automotive Service Excellence

- 1 and the Inter-Industry Conference on Auto Collision Repair, as

- 3 Sec. 2308.353. APPLICATION; FEE. (a) An applicant for an

- 16 <u>full-time</u> automotive technician who holds a certificate that
- 17 authorizes the technician to perform the service.
- 18 Sec. 2308.402. DISPLAY OF CERTAIN INFORMATION. (a) Each
- 19 licensed automotive shop shall display in a place that is visible to
- 20 customers entering the shop:
- 21 (1) the shop's sales tax permit;
- 22 (2) the shop's license certificate; and
- 23 (3) the telephone number for the consumer information
- 24 hotline.
- 25 (b) Each shop shall display the telephone number at which
- 26 consumers may file a complaint with the department.

- 1 Each licensed automotive shop shall maintain a copy of the
- 2 automotive technician certificate for each technician employed by
- 3 the shop and shall provide the copies for inspection at the request
- 4 of a customer or a representative of the department.
- 5 Sec. 2308.404. ADVERTISING. Each licensed automotive shop
- 6 shall provide its license number in each advertisement for the
- 7 shop.
- 8 Sec. 2308.405. ESTIMATES. (a) Each licensed automotive
- 9 shop shall provide to each customer a clear written estimate of the
- 10 charges for repair and diagnostic services authorized by the
- 11 customer.
- 12 (b) Each estimate must include the automotive shop's
- 13 license number.
- 14 (c) An estimate for a diagnostic service must clearly state
- 15 whether the fee for the diagnostic service includes returning the
- 16 <u>automobile to the condition it was in before the diagnostic</u>
- 17 services were performed. Unless a licensed automotive shop receives
- 18 specific authorization from the customer, the shop may not charge a
- 19 fee for tearing down or inspecting an automobile if the fee was not
- 20 in the estimate provided to the customer.
- 21 (d) An estimate for a part must clearly state whether the
- 22 estimated price is for a new, used, rebuilt, or remanufactured
- 23 part.
- (e) Each estimate must clearly indicate any service that
- 25 will be performed by another automotive shop.
- 26 (f) Each estimate must state whether the parts and labor in
- 27 the estimate include a warranty. If a warranty is included, the

- 1 <u>estimate must include a statement of warranty.</u>
- 2 (g) An estimate may provide the prices of parts and labor in
- 3 the form of a menu, but the estimate must separately list each type
- 4 of part and labor operation included in the total estimated price.
- 5 (h) A licensed automotive shop may not charge a customer a
- 6 total fee that exceeds by more than 10 percent or \$100, whichever is
- 7 less, the estimated amount, unless the shop first obtains the
- 8 customer's authorization.
- 9 <u>(i) An automotive shop may provide an estimate</u>
- 10 electronically, including by fax or electronic mail.
- 11 Sec. 2308.406. REPAIR ORDER FORM. (a) Each licensed
- 12 automotive shop shall develop and use an order form to allow
- 13 customers to authorize services. The form must include a signature
- 14 line on which a customer may authorize services at a predetermined
- price and a separate line on which a customer may authorize services
- 16 <u>without a prior estimate.</u> The form must provide for recording the
- 17 date, automobile description, automobile mileage, license plate
- 18 number, vehicle identification number, and a description of the
- 19 customer's request or concern about the automobile.
- 20 (b) An automotive shop shall provide a copy of the completed
- 21 repair order form to the customer on request.
- Sec. 2308.407. INVOICE. (a) Each licensed automotive
- 23 shop shall provide an invoice to each customer.
- (b) The invoice must include:
- 25 <u>(1) the name, address, and telephone number of the</u>
- 26 shop;
- 27 (2) the shop's license number;

2	(4) the date the transaction is completed;
3	(5) a description of the automobile, including the
4	vehicle identification number and the automobile's mileage;
5	(6) the customer's name, address, and telephone

7	(7) an itemized list of all labor performed, all
8	material used, and each part replaced, including parts and labor
9	<pre>covered under the automobile's warranty;</pre>
10	(8) a description of each part as new, used, rebuilt,
11	or remanufactured;
12	(9) a list of any repair performed by another shop;
13	(10) a list of any repairs that the shop considers
14	necessary and that the customer declined;
15	(11) the telephone number at which a consumer may file
16	a complaint with the department; and
17	(12) any applicable statement of warranty.

19	SUBCHAPTER J. DISCIPLINARY ACTION AND PROCEDURES
20	Sec. 2308.451. DISCIPLINARY ACTION. A person is subject to
21	the denial of an application or disciplinary action under Section
22	51.353 if the person violates this chapter or a rule adopted under
23	this chapter.
24	Sec. 2308.452. ADMINISTRATIVE PROCEDURES. A proceeding for
25	the denial of a license application or disciplinary action and an
26	appeal from that proceeding is governed by Chapter 2001, Government
27	Code.

2	SUBCHAPTER K. PENALTIES AND ENFORCEMENT PROVISIONS
3	Sec. 2308.501. EMERGENCY AND CEASE AND DESIST ORDERS. (a)
4	The executive director may issue an emergency order as necessary to
5	enforce this chapter if the executive director determines that an
6	emergency exists requiring immediate action to protect the public
7	health and safety.
8	(b) The executive director may issue the emergency order
9	without notice and hearing or with any notice and hearing the
10	executive director considers practicable under the circumstances.
11	The executive director shall set the time and place for a hearing to
12	affirm, modify, or set aside an emergency order that was issued
13	without a hearing.
14	(c) The executive director may issue a cease and desist
15	order.
16	Sec. 2308.502. CRIMINAL PENALTY. (a) A person commits an
17	offense if the person violates this chapter or a rule adopted under
18	this chapter.
19	(b) An offense under this section is a Class C misdemeanor.
20	Sec. 2308.503. TERMINATION OF UTILITY SERVICE. If the
21	commission determines that an automotive shop is operating without
22	a license required by this chapter, the executive director may
23	authorize a political subdivision to:
24	(1) discontinue utility service provided by the
25	political subdivision to the location where the violation is
26	occurring; or
27	(2) require a public utility operating with a

- 1 franchise to use the public right-of-way of the political
- 2 subdivision to discontinue utility service to the location where
- 3 the violation is occurring.
- 4 SECTION 2. Not later than November 1, 2007, the Texas
- 5 Commission of Licensing and Regulation shall appoint initial
- 6 members of the automotive service and repair advisory board. The
- 7 commission shall appoint four members to terms expiring February 1,
- 8 2009, four members to terms expiring February 1, 2011, and four
- 9 members to terms expiring February 1, 2013.
- 10 SECTION 3. Not later than January 1, 2008, the Texas
- 11 Commission of Licensing and Regulation shall adopt rules,
- 12 procedures, forms, and fees under Chapter 2308, Occupations Code,
- 13 as added by this Act.
- 14 SECTION 4. Regardless of whether the applicant meets the

- area listed in Section 2308.302(a), Occupations Code, as added by
- 19 this Act, to an applicant under this section who:
- 20 (1) applies for a certificate not later than December
- 21 31, 2008;
- 22 (2) demonstrates to the satisfaction of the department
- 23 that the applicant has at least five years of experience in the
- 24 area; and
- 25 (3) pays the application fee set by the Texas
- 26 Commission of Licensing and Regulation.
- 27 SECTION 5. Regardless of whether the applicant meets the

- 1 requirements of Subchapter H, Chapter 2308, Occupations Code, as
- 2 added by this Act, the Texas Department of Licensing and Regulation
- 3 shall issue an automotive service writer, advisor, and estimator
- 4 certificate to an applicant under this section who:
- 5 (1) applies for a certificate not later than December
- 6 31, 2008;
- 7 (2) demonstrates to the satisfaction of the department
- 8 that the applicant has:
- 9 (A) at least five years of experience in
- 10 automotive service writing, advising, and estimating; or
- 11 (B) at least 20 hours of automotive service
- 12 advisor training in the five years preceding the date the person
- 13 submits an application under this section; and
- 14 (3) pays the application fee set by the Texas
- 15 Commission of Licensing and Regulation.
- 16 SECTION 6. (a) Except as provided by Subsection (b) of
- this section, this Act takes effect September 1, 2007.
