## A BILL TO BE ENTITLED

1	AN ACT

- 2 relating to the rates of tuition charged to students of
- 3 institutions of higher education.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Section 54.051(c), Education Code, is amended to
- 6 read as follows:
- 7 (c) Unless a different rate is specified by this section,
- 8 tuition for a resident student at a general academic teaching
- 9 institution is \$64 [\$50] per semester credit hour.
- SECTION 2. Sections 54.0512(b) and (d), Education Code, are
- 11 amended to read as follows:
- 12 (b) Tuition for a resident student at a general academic
- 13 teaching institution for whom the rate of tuition would, in the
- absence of this section, be the rate provided by Section 54.051(c)
- 15 is:
- 16 (1) for the 2007-2008 [<del>2000-2001</del>] academic year, \$54
- 17 [\$40] per semester credit hour;
- 18 (2) for the 2008-2009 [2001-2002] academic year, \$56
- 19 [\$42] per semester credit hour;
- 20 (3) for the 2009-2010 [2002-2003] academic year, \$58
- 21 [\$44] per semester credit hour;
- 22 (4) for the 2010-2011 [2003-2004] academic year, \$60
- 23 [\$46] per semester credit hour;
- 24 (5) for the 2011-2012 [ $\frac{2004-2005}{2004}$ ] academic year, \$62

- [\$48] per semester credit hour; and
- 2 (6) for the 2012-2013 [2005-2006] academic year, \$64
- 3 [\$50] per semester credit hour.

- 4 (d) This section expires January 1, 2015 [<del>2008</del>].
- 5 SECTION 3. Sections 54.0513(a) and (b), Education Code, are 6 amended to read as follows:
  - (a) In addition to amounts that a governing board of an institution of higher education is authorized to charge as tuition under the other provisions of this chapter, the governing board[7] under the terms the governing board considers appropriate,] may charge any student for an academic period an amount designated as tuition not to exceed the amount charged to the student under Section 54.051 or 54.0512, as applicable, for that academic period [that the governing board considers necessary for the effective operation of the institution].
    - (b) Subject to the limit provided by Subsection (a) on the amount designated as tuition charged under this section, a [A] governing board may set a different tuition rate under this section for each program and course level offered by each institution of higher education[. A governing board may set a different tuition rate] as the governing board considers appropriate to increase graduation rates, encourage efficient use of facilities, [ex] enhance employee performance, or further another legitimate purpose of the institution.
- SECTION 4. Sections 54.0515(e) and (f), Education Code, are amended to read as follows:
- (e) It is the legislature's intent that each institution of

- 1 higher education[, as a condition to tuition deregulation under
- 2 Section 54.0513, reasonably implement the following:
- 3 (1) each institution shall make satisfactory progress
- 4 towards the goals provided in its master plan for higher education
- 5 and in "Closing the Gaps," the state's master plan for higher
- 6 education; and
- 7 (2) each institution shall meet acceptable
- 8 performance criteria, including measures such as graduation rates,
- 9 retention rates, enrollment growth, educational quality, efforts
- 10 to enhance minority participation, opportunities for financial
- 11 aid, and affordability.
- 12 (f) The committee shall:
- 13 (1) meet at the call of either chair;
- 14 (2) monitor and regularly report to the legislature on
- 15 each institution of higher education's compliance with the
- 16 requirements of Subsection (e); and
- 17 (3) receive and review information concerning the
- 18 affordability and accessibility of higher education[, including
- 19 the impact of tuition deregulation].
- 20 SECTION 5. Subchapter B, Chapter 56, Education Code, is
- 21 repealed.
- 22 SECTION 6. (a) The changes in law made by this Act apply
- 23 beginning with tuition charged by an institution of higher
- 24 education for the 2007-2008 academic year. Tuition charged by an
- 25 institution of higher education in an academic year before that
- 26 academic year is covered by the law in effect before the effective
- 27 date of this Act, and the former law is continued in effect for that

- 2 (b) Tuition set aside under Subchapter B, Chapter 56,
- 3 Education Code, before the 2007-2008 academic year that was not
- 4 used as provided by that subchapter before that academic year shall
- 5 be used as provided by that subchapter as it existed immediately
- 6 before the effective date of this Act, and that subchapter is
- 7 continued in effect for that purpose.
- 8 SECTION 7. This Act takes effect immediately if it receives
- 9 a vote of two-thirds of all the members elected to each house, as
- 10 provided by Section 39, Article III, Texas Constitution. If this
- 11 Act does not receive the vote necessary for immediate effect, this
- 12 Act takes effect September 1, 2007.
