(a) The Texas Structural Pest Control Board 11 is abolished but continues in existence until March 1, 2008, for the 12 sole purpose of transferring obligations, property, full-time 13 14 equivalent positions, rights, powers, and duties to the Department 15 of Agriculture. The Department of Agriculture assumes all of the obligations, property, full-time equivalent positions, rights, 16 17 powers, and duties of the Texas Structural Pest Control Board, as it exists immediately before the effective date of this Act. 18 unexpended funds appropriated to the Texas Structural Pest Control 19 Board are transferred to the Department of Agriculture. 20 21 transfer of the obligations, property, full-time equivalent positions, rights, powers, and duties of the Texas Structural Pest 22 Control Board to the Department of Agriculture must be completed 23 24 not later than March 1, 2008.
- 25 (b) All rules of the Texas Structural Pest Control Board are 26 continued in effect as rules of the Department of Agriculture until 27 superseded by a rule of the Department of Agriculture. A

- certificate, license, or permit issued by the Texas Structural Pest Control Board is continued in effect as provided by the law in effect immediately before the effective date of this Act. A complaint, investigation, contested case, or other proceeding pending on the effective date of this Act is continued without change in status after the effective date of this Act. inspection or other activity conducted by the Texas Structural Pest Control Board is considered to be an inspection or activity conducted by the Department of Agriculture.
- 10 (c) A reference in another law or an administrative rule to 11 the Texas Structural Pest Control Board means the Department of 12 Agriculture.

- SECTION 3.02. (a) The Texas Structural Pest Control Board, in cooperation with and at the direction of the Department of Agriculture, shall complete all necessary computer programming and other tasks to ensure that the agency numbers assigned by the comptroller to the board and the department are not necessary for any fiscal year after 2007, except to complete earlier fiscal year revenue and expenditure transactions and reporting. The number assigned by the comptroller to the Department of Agriculture shall be used to record transactions related to the regulation of structural pest control beginning in fiscal year 2008.
- (b) Not later than July 1, 2007, the Texas Structural Pest Control Board shall request that the comptroller grant the Department of Agriculture inquiry-only security access to the uniform statewide accounting system, the state property accounting system, the uniform statewide payroll system, and the human

- 1 resources information system for the board. The Department of
- 2 Agriculture and the comptroller may coordinate implementation of
- 3 this section.
- 4 (c) Not later than July 15, 2007, the Department of
- 5 Agriculture shall provide to the Texas Structural Pest Control
- 6 Board detailed information regarding the board's responsibilities
- 7 under Subsection (a) of this section.
- 8 SECTION 3.03. The change in law made by this Act with
- 9 respect to conduct that is grounds for imposition of a disciplinary
- 10 sanction, including an emergency suspension or a cease and desist
- order, applies only to conduct that occurs on or after September 1,
- 12 2007. Conduct that occurs before September 1, 2007, is governed by
- 13 the law in effect on the date the conduct occurred, and the former
- 14 law is continued in effect for that purpose.
- 15 SECTION 3.04. Not later than September 1, 2008, the
- 16 Department of Agriculture shall adopt rules and policies required
- 17 under:
- 18 (1) Section 1951.105, Occupations Code, as amended by
- 19 this Act;
- 20 (2) Section 1951.207(a)(2), Occupations Code, as
- 21 amended by this Act;
- 22 (3) Section 1951.212(d), Occupations Code, as amended
- 23 by this Act; and
- 24 (4) Section 1951.406, Occupations Code, as added by
- 25 this Act.
- SECTION 3.05. Not later than September 1, 2008, the
- 27 commissioner of agriculture shall appoint the initial members of

- 1 the structural pest control advisory committee under Section
- 2 1951.101, Occupations Code, as amended by this Act.
- 3 SECTION 3.06. Not later than September 1, 2008, each school
- 4 district shall provide the name, address, telephone number, and
- 5 e-mail address of the district's integrated pest management
- 6 coordinator to the Department of Agriculture as required by Section
- 7 1951.212(e), Occupations Code, as amended by this Act.
- 8 SECTION 3.07. (a) Except as provided by Subsection (b) of
- 9 this section, this Act takes effect September 1, 2007.
- 10 (b) Section 3.02 of this Act takes effect immediately if
- 11 this Act receives a vote of two-thirds of all the members elected to
- 12 each house, as provided by Section 39, Article III, Texas
- 13 Constitution. If this Act does not receive the vote necessary for
- 14 immediate effect, Section 3.02 does not take effect.
