- 14 (c) A person commits an offense if the person offers to sell
- or sells ammonium nitrate or ammonium nitrate material and does not
- 16 <u>hold a registration issued under this subchapter.</u>
- 17 (d) An offense under Subsection (a) or (c) is a Class A
- 18 misdemeanor.
- (e) An offense under Subsection (b) is a felony of the third
- 20 degree.
- 21 (f) It is an exception to the application of Subsection (b)
- 22 that the person holds a permit or license issued under 18 U.S.C.
- 23 Section 843.
- 24 (g) If conduct constituting an offense under this section is
- also an offense under another law, the actor may be prosecuted under
- this section, the other law, or both.
- 27 SECTION 2. (a) Section 63.154, Agriculture Code, as added

- 1 by this Act, applies only to a sale of ammonium nitrate or ammonium
- 2 nitrate material that is initiated on or after the effective date of
- 3 this Act. A sale of ammonium nitrate or ammonium nitrate material
