<u>\$8,000</u> [\$15,000] has been received by the 1 (B) department from the issuance of license plates for that sports 2 3 team; or 4 \$8,000 [\$15,000] has been deposited with the (C) 5 department for the continued issuance of license plates for that 6 sports team. Sections 504.702(b) and (c), Transportation SECTION 2. 7 8 Code, are amended to read as follows: The department may manufacture the specialty license 9 (b) plates only if a request for manufacture of the license plates is 10 filed with the department. The request must be: 11 (1) made on a form adopted by the department; 12 (2) filed before the fifth anniversary 13 of the 14 effective date of the law that authorizes the issuance of the 15 specialty license plates; and (3) 16 accompanied by: 17 (A) a deposit of \$8,000 [\$15,000]; or (B) applications for issuance of at least 1,900 18 [3,500] sets of the license plates plus the fees for issuance of 19 20 that number of sets. (c) Money deposited with the department under Subsection 21 (b)(3)(A) shall be returned to the person who made the deposit only 22 if 1,900 [3,500] sets of the applicable license plates are issued or 23 24 presold. 25 SECTION 3. The change in law made by this Act applies only to a request for the manufacture of specialty license plates 26 received by the department on or after the effective date of this 27

1 Act. The change in law does not affect a request for the 2 manufacture of specialty license plates made before the effective 3 date of this Act, and the former law is continued in effect for that 4 purpose.
