4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Section 12.05, Alcoholic Beverage Code, is
6	amended to read as follows:
7	Sec. 12.05. SALES BY CERTAIN BREWERS. (a) The holder of a
8	brewer's permit whose annual production of ale in this state does
9	not exceed, together with the annual production of beer by the
10	holder of a manufacturer's license acting under the authority of
11	Section 62.12 [of this code] at the same premises, a total of 75,000
12	barrels, may:
13	(1) sell ale produced under the permit to those
14	persons to whom the holder of a general class B wholesaler's permit
15	may sell malt liquor under Section 20.01(3); and
16	(2) subject to Subsection (c), sell ale to ultimate
17	<pre>consumers:</pre>
18	(A) for consumption on the brewer's premises; or
19	(B) in unbroken packages for off-premises
20	<pre>consumption [of this code].</pre>
21	(b) With regard to $[such]$ a sale under Subsection (a)(1),
22	the brewer has the same authority and is subject to the same
23	requirements that apply to a sale made by the holder of a general

class B wholesaler's permit.

- 1 (c) Sales of ale under Subsection (a)(2), together with the
- 2 sales of beer by the holder of a manufacturer's license acting under
- 3 the authority of Section 62.12(a)(2) at the same premises, may not
- 4 exceed 5,000 barrels annually.
- 5 SECTION 2. Section 62.12, Alcoholic Beverage Code, is
- 6 amended to read as follows:
- 7 Sec. 62.12. SALES BY CERTAIN MANUFACTURERS. (a) A
- 8 manufacturer's licensee whose annual production of beer in this
- 9 state, together with the annual production of ale by the holder of a
- 10 brewer's permit acting under the authority of Section 12.05 at the
- 11 <u>same premises</u>, does not exceed 75,000 barrels may:
- 12 (1) sell beer produced under the license to those
- 13 permittees, licensees, and persons to whom a general distributor's
- 14 licensee may sell beer under Section 64.01(a)(2); and
- 15 (2) subject to Subsection (a-2), sell beer to ultimate
- 16 consumers:
- 17 (A) for consumption on the manufacturer's
- 18 premises; or
- 19 <u>(B) in unbroken packages for off-premises</u>
- consumption [64.01(2) of this code].
- 21 (a-1) With regard to [such] a sale under Subsection (a)(1),
- the manufacturer has the same authority and is subject to the same
- 23 requirements as apply to a sale made by a general distributor's
- 24 licensee.
- 25 (a-2) Sales of beer under Subsection (a)(2), together with
- the sales of ale by the holder of a brewer's permit acting under the
- 27 authority of Section 12.05(a)(2) at the same premises, may not

- 1 <u>exceed 5,000 barrels annually.</u>
- 2 (b) The authority granted by this section is additional to
- 3 that granted by Section 62.01 [of this code].
- 4 SECTION 3. This Act takes effect September 1, 2007.
