Section 2301.257(b), Occupations Code, is amended to read as follows: 7 (b) If a material change occurs in the information included 8 in an application for a dealer's license, the dealer shall notify 9 the director [board] of the change within a reasonable time [but not 10 11 later than the next annual renewal]. The director [board] shall 12 prescribe a form for the disclosure of the change. 13 SECTION 2. Section 2301.264, Occupations Code, is amended 14 by amending Subsection (a) and adding Subsections (e) and (f) to read as follows: 15 The annual fees for a license issued under this chapter 16 (a) are: 17 \$900 for a manufacturer or distributor, plus \$20 18 (1)for each dealer franchised by the manufacturer or distributor; 19 (2) for a franchised dealer: 20 21 (A) \$175, if the dealer sold fewer than 201 new 22 motor vehicles during the preceding calendar year; \$275, if the dealer sold more than 200 but 23 (B) fewer than 401 new motor vehicles during the preceding calendar 24

No. 2651 1 fewer than 1,201 motor vehicles during the preceding calendar year; \$625, if the lessor leased more than 1,200 2 (E) 3 but fewer than 1,601 motor vehicles during the preceding calendar 4 year; and 5 (F) \$750, if the lessor leased more than 1,600 6 motor vehicles during the preceding calendar year; and (6) [<del>(7)</del>] \$375 for a vehicle lease facilitator[<del>; and</del> 7 8 [(8) \$50 for a duplicate license]. 9 The fee for an amendment to a license under this chapter (e) 10 is \$25. (f) The fee for a duplicate license under this chapter is 11 12 \$50. SECTION 3. The heading to Section 2301.301, Occupations 13 14 Code, is amended to read as follows: 15 Sec. 2301.301. LICENSE TERM AND [ANNUAL] RENEWAL [REQUIRED]. 16 Section 2301.301, Occupations Code, is amended 17 SECTION 4. by amending Subsections (a), (b), and (c) and adding Subsection (e) 18 to read as follows: 19 Licenses [A license] issued under this chapter are valid 20 (a) 21 for the period prescribed by the commission [expires on the first anniversary of the date the license is issued]. 22 The director [board] may issue a license for a term of 23 (b) 24 less than the period prescribed under Subsection (a) [one year] to coordinate the expiration dates of licenses held by a person that is 25 26 required to obtain more than one license to perform activities 27 under this chapter.

1 (c) The <u>commission</u> [board] by rule may implement a system 2 under which licenses expire on various dates during the year. If a license is issued or renewed for a term that is less than the period 3 set under Subsection (a) [For a year in which a license expiration 4 5 date is changed], the fee for the license shall be prorated so that 6 the license holder pays only that portion of the fee that is allocable to the number of months during which the license is valid. 7 8 On renewal of the license on the new expiration date, the entire 9 license renewal fee is payable.

10 (e) If the commission prescribes the term of a license under 11 this chapter for a period other than one year, the commission shall 12 prorate the applicable annual fee required under this chapter as 13 necessary to reflect the term of the license.

SECTION 5. Section 2301.303, Occupations Code, is amended to read as follows:

Sec. 2301.303. RENEWAL OF DEALER'S LICENSE. A dealer shall renew the dealer's license [annually] on an application prescribed by the <u>director</u> [board]. The <u>director</u> [board] shall include in the renewal application a request for disclosure of material changes described by Section 2301.257.

21 SECTION 6. Sections 503.007(a), (b), and (c), 22 Transportation Code, are amended to read as follows:

(a) The fee for an original general distinguishing number is
\$500 for the first year and \$200 for each subsequent year for which
<u>the number is valid</u>.

(b) The fee for the renewal of a general distinguishing
number is \$200 <u>a year</u>.

(a) 6 (b) The fee for a manufacturer's license plate is \$40 <u>a</u> 7 year. 8 (c) The fee for an additional set of drive-a-way in-transit license plates is \$5 a year. 9 SECTION 8. Subchapter A, Chapter 503, Transportation Code, 10 is amended by adding Sections 503.010, 503.011, and 503.012 to read 11 12 as follows: Sec. 503.010. TERM OF GENERAL DISTINGUISHING NUMBER, 13 LICENSE, OR LICENSE PLATE. Each general distinguishing number, 14 15 license, or license plate issued under this chapter is valid for the period prescribed by the commission. 16 17 Sec. 503.011. PRORATING FEES. If the commission prescribes the term of a general distinguishing number, license, or license 18 plate under this chapter for a period other than one year, the 19 commission shall prorate the applicable annual fee required under 20 21 this chapter as necessary to reflect the term of the number, license, or license plate. 22 Sec. 503.012. COLLECTED MONEY. Section 403.095, Government 23 24 Code, does not apply to money received by the department and deposited to the credit of the state highway fund in accordance with 25 26 this chapter. SECTION 9. Sections 503.032(a) and (c), Transportation 27

location is considered to be an established and permanent place of

8 (1) owns the real property on which the business is 9 situated or has a written lease for the property that has a term of 10 not less than <u>the term of the general distinguishing number</u> [<del>one</del> 11 <del>year</del>];

maintains on the location: 12 (2) a permanent furnished office that is equipped 13 (A) 14 as required by the department for the sale of the vehicles of the 15 type specified in the application; and (B) a conspicuous sign with letters at least six 16 17 inches high showing the name of the applicant's business; and (3) has sufficient space on the location to display at 18 least five vehicles of the type specified in the application. 19 The applicant must demonstrate that: 20 (c) 21 the applicant intends to remain regularly and (1)actively engaged in the business specified in the application for a 22 time equal to at least the term of the general distinguishing number 23 24 [one year] at the location specified in the application; and (2) the applicant or a bona fide employee of the 25

(A) at the location to buy, sell, lease, or

11 SECTION 11. Section 503.0618(c), Transportation Code, is 12 amended to read as follows:

15 SECTION 12. Section 503.066(d), Transportation Code, is 16 amended to read as follows:

17 (d) A metal license plate issued under this chapter expires
18 on the same date as the expiration of the [dealer] license <u>under</u>
19 [to] which it is issued.

SECTION 13. The changes in law made by this Act to the 20 issuance and renewal of a license under Chapter 2301, Occupations 21 Code, and a license, general distinguishing number, or license 22 plate under Chapter 503, Transportation Code, apply only to a 23 24 license, general distinguishing number, or license plate that is originally issued or is renewed on or after the effective date of 25 26 this Act. A license, general distinguishing number, or license 27 plate that is issued or renewed before that date is governed by the

- 1 law in effect on the date of issuance or renewal, and the former law 2 is continued in effect for that purpose.
- 3 SECTION 14. This Act takes effect September 1, 2007.
