- SECTION 1. Section 521.103, Transportation Code, is amended 7 by adding Subsections (c), (d), and (e) to read as follows: 8
- (c) For a personal identification certificate issued or 9 renewed under this section, the department shall print "RSO" on the 10 11 face of the personal identification certificate:
- 12 (1) in black;

- 13 (2) in the space in which the department prints the 14 state flag; and
- (3) in the same size font as the department prints 15 "TEXAS" on the face of the personal identification certificate. 16
- (d) The department may collect an additional fee to 17 18 implement the requirements of Subsection (c).
- (e) The department shall post information on the 19 department's Internet website explaining that a person whose 20 21 personal identification certificate has "RSO" on the certificate is 22 subject to the registration requirements of Chapter 62, Code of
- 23 Criminal Procedure.
- SECTION 2. Section 521.272, Transportation Code, is amended 24
