exceed \$500 if each portion of the expenditure:

(1) is made by a registrant; and

SECTION 3. (a) The change in law made by this Act applies only to the making or reporting under Chapter 305, Government Code, of an expenditure made on or after September 1, 2007. The making or reporting under Chapter 305, Government Code, of an expenditure made before September 1, 2007, is governed by the law in effect at the time the expenditure is made, and the former law is continued in effect for that purpose.

(b) The change in law made by this Act applies only to an offense committed on or after September 1, 2007. For the purposes of this section, an offense is committed before September 1, 2007, if any element of the offense occurs before that $\bar{\text{date}}$. An offense committed before September 1, 2007, is covered by the law in effect when the offense was committed, and the former law is continued in effect for that purpose.

SECTION 4. This Act takes effect September 1, 2007.
