	A BILL TO BE ENTITLED
1	AN ACT
2	relating to appointing a commission to study and develop a
3	recommended technical high school graduation program.
4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Subchapter F, Chapter 29, Education Code, is
6	amended by adding Section 29.189 to read as follows:
7	Sec. 29.189. TEXAS CAREER-ACADEMIC TRAINING AND STATEWIDE
8	CURRICULUM COMMISSION. (a) In this section, "skilled employee"
9	means an employee who has acquired knowledge in a technical field
10	sufficient to successfully perform assigned duties.
11	(b) The Texas Career-Academic Training and Statewide
12	Curriculum Commission is established to perform a study and make
13	recommendations to the legislature concerning a technical high
14	school graduation program.
15	(c) The commission is composed of 14 members appointed by
16	the State Board of Education as follows:
17	(1) a superintendent from one of the five school
18	districts in the state with the greatest student enrollment;
19	(2) a superintendent from one of the 100 school
20	districts in the state with the smallest student enrollment;
21	(3) a high school teacher currently employed by one of
22	the five school districts in the state with the greatest student
23	enrollment, other than the district from which the superintendent
24	is appointed under Subdivision (1);

1	(4) a high school teacher currently employed by one of
2	the 100 school districts in the state with the smallest student
3	enrollment, other than the district from which the superintendent
4	is appointed under Subdivision (2);
5	(5) a retired high school teacher who was formerly
6	employed by one of the five school districts in the state with the
7	greatest student enrollment, other than the district from which the
8	superintendent is appointed under Subdivision (1);
9	(6) a retired high school teacher who was formerly
10	employed by one of the 100 school districts in the state with the
11	smallest student enrollment, other than the district from which the
12	superintendent is appointed under Subdivision (2);
13	(7) a high school guidance counselor;
14	(8) a representative from a private trade or technical
15	school accredited by an accrediting entity recognized by the
16	commissioner or by another state officer or agency;
17	(9) a representative from a component of the Texas
18	State Technical College System;
19	(10) three persons who are leaders in the business
20	community in this state, each from a different business
21	organization that employs skilled employees;
22	(11) a representative of the Texas Workforce
23	Commission; and
24	(12) a person with expertise in technical
25	opportunities in the public education setting.
26	(d) For purposes of Subsection (c), the size of a school
27	district is based on student enrollment on January 1, 2007.

1	(e) The Texas Career-Academic Training and Statewide
2	Curriculum Commission shall:
3	(1) research courses currently offered in public high
4	schools across this state and in other states that are usually
5	offered for high school graduation credit and that are appropriate
6	for a technical high school curriculum;
7	(2) develop a technical high school graduation program
8	to recommend to the legislature for implementation in public high
9	schools in this state; and
10	(3) prepare a fiscal report relating to the cost of
11	implementing the technical high school graduation program
12	recommended under Subdivision (2) that includes a recommendation
13	relating to methods of funding by the state or other entities to
14	avoid imposition of a significant financial burden on school
15	districts.
16	(f) A technical high school graduation program developed
17	under Subsection (e) must:
18	(1) include electives that provide a student with the
19	opportunity to learn skills necessary to acquire employment that
20	provides a decent wage and opportunity for advancement;
21	(2) be coordinated with existing high school
22	graduation programs established under Section 28.025 in a manner
23	that allows students to alternate between graduation programs;
24	(3) include requirements for graduation that are more
25	rigorous than the requirements under the minimum high school
26	program established under Section 28.025 and sufficient to allow a
27	student to apply for postsecondary study but that are less rigorous

1	than the requirements under the recommended high school program
2	established under Section 28.025; and
3	(4) be approved by a majority of the members of the
4	Texas Career-Academic Training and Statewide Curriculum
5	Commission.
6	(g) Not later than December 1, 2008, the Texas
7	Career-Academic Training and Statewide Curriculum Commission shall
8	submit a report relating to the technical high school graduation
9	program developed under this section to the governor, the
10	lieutenant governor, the speaker of the house of representatives,
11	and the presiding officers of the standing committees of each house
12	of the legislature with primary jurisdiction over public education.
13	(h) This section expires December 31, 2008.

SECTION 2. Not later than November 1, 2007, the State Board of Education shall appoint members to the Texas Career-Academic Training and Statewide Curriculum Commission as established by Section 29.189, Education Code, as added by this Act.

18 SECTION 3. This Act takes effect immediately if it receives 19 a vote of two-thirds of all the members elected to each house, as 20 provided by Section 39, Article III, Texas Constitution. If this 21 Act does not receive the vote necessary for immediate effect, this 22 Act takes effect September 1, 2007.
