- 13 member accrues under Section 835.1015(a). After including any
- increase under Subsection (b), the service retirement annuity under
- this subsection may not be an amount that is greater than 90 [80]

- SECTION 2. Sections 839.102(d) and (f), Government Code,
- 18 are amended to read as follows:
- 19 (d) The service retirement annuity of a member qualifying
- 20 for retirement under Section 839.101(a) is the applicable state
- 21 salary under Subsection (a) multiplied by a percentage amount that
- 22 is the sum of 50 percent plus the product of 2.3 [two] percent
- 23 multiplied by the number of years of subsequent service credit the
- 24 member accrues under Section 840.1025(a). After including any

- 1 increase under Subsection (b), the service retirement annuity under

- 4 (f) The service retirement annuity of a member qualifying
- for retirement under Section 839.101(a)(4) is the applicable state
- 6 salary under Subsection (a) multiplied by a percentage amount that
- 7 is the sum of 50 percent plus the product of 2.3 [two] percent
- 8 multiplied by the number of years of subsequent service credit the
- 9 member accrues under Section 840.1027. After including any
- increase under Subsection (b), the service retirement annuity under
- 11 this subsection may not be an amount that is greater than 90 [80]
- 12 percent of the applicable salary under Subsection (a).
- SECTION 3. The changes in law made by this Act apply only to
- 14 a member of the Judicial Retirement System of Texas Plan One or the
- 15 Judicial Retirement System of Texas Plan Two who retires on or after
- 16 the effective date of this Act. A member who retires before the
- 17 effective date of this Act is governed by the law in effect
- 18 immediately before that date, and the former law is continued in
- 19 effect for that purpose.
- SECTION 4. This Act takes effect September 1, 2007.
