A BILL TO BE ENTITLED

1 AN ACT

- 2 relating to an award for certain members of the state military
- 3 forces who served in defense support to a civilian authority
- 4 mission.
- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 6 SECTION 1. Section 431.134, Government Code, is amended to
- 7 read as follows:
- 8 Sec. 431.134. OTHER AWARDS. The adjutant general may adopt
- 9 rules and regulations relating to the:
- 10 (1) Texas Faithful Service Medal, which shall be
- awarded to a member of the state military forces who has completed
- 12 five years of honorable service during which the person has shown
- 13 fidelity to duty, efficient service, and great loyalty to the
- 14 state;
- 15 (2) Federal Service Medal, which shall be awarded to a
- 16 person who was inducted into federal service from the state
- military forces between June 15, 1940, and January 1, 1946, or after
- June 1, 1950, if the service was for more than 90 days;
- 19 (3) Texas Medal of Merit, which may be presented to a
- 20 member of the military forces of this state, another state, or the
- 21 United States who performs outstanding service or attains
- 22 extraordinary achievement in behalf of the state or United States;
- 23 (4) Texas Outstanding Service Medal, which may be
- 24 presented to a member of the military forces of this state, another

- 1 state, or the United States who has performed service in a superior
- 2 and clearly outstanding manner;
- 3 (5) Texas State Guard Service Medal, which shall be
- 4 awarded to a person who completes three consecutive years of
- 5 honorable service in the Texas State Guard during which the person
- 6 has shown fidelity to duty, efficient service, and great loyalty to
- 7 the state;
- 8 (6) Texas Desert Shield/Desert Storm Campaign Medal,
- 9 which shall be awarded to a person who was inducted into federal
- 10 service from the Texas National Guard after August 1, 1990, in
- 11 support of Operation Desert Shield or Operation Desert Storm,
- 12 without regard to the place that the person was deployed while
- 13 serving on active federal military duty;
- 14 (7) Texas Humanitarian Service Medal, which shall be
- 15 awarded to a person who:
- 16 (A) does not meet the criteria for an award of the
- 17 federal Humanitarian Service Medal;
- 18 (B) is a member of the state military forces; and
- 19 (C) while serving under state active duty orders,
- 20 participates satisfactorily in the accomplishment of missions to
- 21 protect life or property during or soon after a natural disaster or
- 22 civil unrest;
- 23 (8) Texas Cavalry Medal, which shall be awarded to a
- 24 person who:
- 25 (A) served on or after September 11, 2001, in the
- 26 124th Cavalry, Texas Army National Guard; and
- 27 (B) served in a hostile fire zone as designated

- 1 by the United States secretary of defense;
- 2 (9) Texas Combat Service Ribbon, which shall be
- 3 awarded to a member of the Texas National Guard who served, after
- 4 September 11, 2001, in a hostile fire zone as designated by the
- 5 United States secretary of defense; [and]
- 6 (10) Texas Purple Heart Medal, which shall be awarded
- 7 to a person who, after September 11, 2001:
- 8 (A) was inducted into federal service from the
- 9 Texas National Guard; and
- 10 (B) meets the criteria for an award of the
- 11 federal Purple Heart Medal; and
- 12 (11) Texas Homeland Defense Service Medal, which shall
- be awarded to a member of the state military forces who served:
- 14 (A) on or after September 11, 2001;
- (B) on state active duty or active duty under
- 16 state authority in accordance with Title 32 of the United States
- 17 Code; and
- 18 (C) satisfactorily in defense support to a
- 19 mission in the state under civilian authority.
- 20 SECTION 2. This Act takes effect immediately if it receives
- 21 a vote of two-thirds of all the members elected to each house, as
- 22 provided by Section 39, Article III, Texas Constitution. If this
- 23 Act does not receive the vote necessary for immediate effect, this
- 24 Act takes effect September 1, 2007.
