## A BILL TO BE ENTITLED

1	AN ACT
2	relating to a study of methods for increasing the availability of
3	certain information on energy efficiency of certain residential
4	property.
5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
6	SECTION 1. Chapter 2305, Government Code, is amended by
7	adding Subchapter F to read as follows:
8	SUBCHAPTER F. RESIDENTIAL ENERGY EFFICIENCY STUDY
9	Sec. 2305.101. DEFINITIONS. In this subchapter:
10	(1) "Residential real property" means a detached
11	one-family or two-family dwelling.
12	(2) "Energy efficiency mortgage" means a mortgage that
13	provides financing incentives for:

- 14 (A) the purchase of energy efficient residential
- 15 real property; or
- (B) energy efficiency improvements to existing 16
- 17 residential housing by incorporating the cost of the improvements
- 18 into the mortgage.
- Sec. 2305.102. STUDY: METHODS FOR PROVIDING ENERGY 19
- EFFICIENCY INFORMATION FOR RESIDENTIAL REAL PROPERTY. (a) The 20
- energy office shall conduct a study to examine methods for 21
- introducing information into the residential real property 22
- 23 marketplace regarding energy efficiency of residential real
- 24 property.

1	(b) The energy office shall establish an advisory committee
2	to direct the focus of the study. The advisory committee shall be
3	<pre>composed of:</pre>
4	(1) state and local government agencies involved in
5	residential housing programs;
6	(2) builders;
7	(3) organizations that develop and adopt uniform
8	<pre>building codes;</pre>
9	(4) organizations that study and develop techniques
10	and standards to enhance energy efficiency;
11	(5) utilities;
12	(6) real estate agents;
13	(7) mortgage lenders;
14	(8) financial agencies involved in mortgage markets;
15	<u>and</u>
16	(9) representatives from any other appropriate
17	industry or other interested members of the public, as determined
18	by the energy office.
19	(c) The study shall consider, at a minimum:
20	(1) establishing standards for rating the energy
21	efficiency of new and existing residential real property, and
22	providing information that reflects the manner in which that rating
23	would change if certain recommended improvements were made;
24	(2) establishing procedures to ensure that new and
25	existing residential real properties can receive an energy
26	efficiency rating in the six months before the time of sale and that
27	any rating performed may be communicated to potential buyers;

Τ	(3) possible methods for creating incentives for the
2	growth and development of the market for home energy ratings;
3	(4) including a dedicated field in residential real
4	property listings to allow for the provision of certain information
5	regarding the energy efficiency of the residence, including:
6	(A) past utility bills; or
7	(B) an energy efficiency rating;
8	(5) possible methods for delivering energy efficiency
9	mortgages to the buyers of properties that meet a minimum standard
10	for energy efficiency; and
11	(6) creating public awareness of the energy efficiency
12	rating system and the availability of energy efficiency mortgages.
13	(d) The study must:
14	(1) address the question of whether introducing
15	information into the marketplace regarding energy efficiency of
16	residential real property through the method the advisory committee
17	and the energy office determine most promising is likely to
18	increase the average energy efficiency of residential real property
19	in this state; and
20	(2) specify any statutory changes the advisory
21	committee and the energy office determine are necessary to achieve
22	a particular result.
23	(e) To obtain information to conduct the study, the advisory
24	committee or the energy office may contract with appropriate
25	organizations, public or private institutions of higher education,
26	and any other appropriate entities. State agencies, boards, and
27	commissions and institutions of higher education shall comply with

- 3 (f) The energy office shall report to the governor, the
- 4 <u>lieutenant</u> governor, and the speaker of the house of
- 5 representatives on the study and its results not later than October

- 7 Sec. 2305.103. EXPIRATION. This subchapter expires August
- 8 31, 2009.
- 9 SECTION 2. This Act takes effect September 1, 2007.
