- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Section 48.002, Business & Commerce Code, as
- 6 added by Chapter 298, Acts of the 79th Legislature, Regular
- 7 Session, 2005, is amended by adding Subdivisions (1-a), (10), and
- 8 (11) to read as follows:
- 9 "Botnet" means a collection of zombies.
- 10 "Unsolicited commercial electronic mail message"
- 11 has the meaning assigned by Section 46.001.
- 12 <u>(11) "Zombie" means a computer that, without the</u>
- 13 knowledge and consent of the computer's owner or operator, has been
- 14 compromised to give access or control to a program or person other
- than the computer's owner or operator.
- SECTION 2. Section 48.054, Business & Commerce Code, as
- 17 added by Chapter 298, Acts of the 79th Legislature, Regular
- 18 Session, 2005, is amended to read as follows:
- 19 Sec. 48.054. KNOWING VIOLATION. A person knowingly
- 20 violates Section 48.051, 48.052, [ex] 48.053, or 48.057 if the
- 21 person:
- 22 (1) acts with actual knowledge of the facts that
- 23 constitute the violation; or
- 24 (2) consciously avoids information that would

- 1 establish actual knowledge of those facts.
- 2 SECTION 3. Subchapter B, Chapter 48, Business & Commerce
- 3 Code, as added by Chapter 298, Acts of the 79th Legislature, Regular
- 4 Session, 2005, is amended by adding Section 48.057 to read as
- 5 follows:
- 6 Sec. 48.057. UNAUTHORIZED CREATION OR USE OF ZOMBIES OR
- 7 BOTNETS. (a) If a person is not the owner or operator of the
- 8 computer, the person may not knowingly cause or offer to cause the
- 9 computer to become a zombie or part of a botnet for purposes of
- sending an unsolicited commercial electronic mail message.
- 11 (b) A person may not knowingly create, have created, use, or
- offer to use a zombie or botnet to send an unsolicited commercial
- 13 <u>electronic mail message.</u>
- 14 (c) A person may not for purposes of sending an unsolicited
- 15 <u>commercial electronic mail message:</u>
- 16 (1) purchase, rent, or otherwise gain control of a
- zombie or botnet created by another person; or
- 18 (2) sell, lease, offer for sale or lease, or otherwise
- 19 provide to another person access to or use of a zombie or botnet.
- SECTION 4. The changes in law made by this Act apply only to
- 21 conduct that occurs on or after the effective date of this Act.
- 22 Conduct that occurs before the effective date of this Act is
- 23 governed by the law in effect at the time the conduct occurred, and
- that law is continued in effect for that purpose.
- 25 SECTION 5. This Act takes effect September 1, 2007.
