16	terms of three members expiring February 1 of each odd-numbered
17	year.
18	Sec. 35.003. VACANCY. In the event of a vacancy, the
19	governor shall appoint a replacement to fill the unexpired portion
20	of the term.
21	Sec. 35.004. PRESIDING OFFICER. The governor shall
22	designate a member of the commission as the presiding officer of the
23	commission to serve in that capacity at the will of the governor.
24	The presiding officer may vote on all matters before the

- 2 Sec. 35.005. QUALIFICATIONS. (a) Each member must be a
- 3 <u>registered voter of the state.</u>
- 4 (b) A member of the commission may not hold any other public

- 8 Sec. 35.007. ADMINISTRATIVE SUPPORT. (a) The Office of
- 9 Court Administration of the Texas Judicial System shall provide
- 10 administrative support for the commission. The commission is
- 11 entitled to receive staff support, meeting facilities, temporary
- 12 work facilities, including computer, telephone, reproduction, and
- 13 facsimile equipment, available data, and other resources from the
- 14 office as necessary to carry out the commission's powers and
- 15 duties.
- 16 (b) The Office of Court Administration of the Texas Judicial
- 17 System shall grant all reasonable requests for staff support and
- 18 resources under this section.
- 19 Sec. 35.008. COMPENSATION AND REIMBURSEMENT. (a) A member
- of the commission may not receive compensation for the member's
- 21 service on the commission.
- 22 (b) The Office of Court Administration of the Texas Judicial
- 23 System shall reimburse a member for all actual and reasonable
- 24 expenses incurred in the exercise of powers and performance of
- 25 duties under this chapter.

3	Sec. 35.101. MEETINGS. The commission shall meet at the		
4	call of the presiding officer or at the request of a majority of the		
5	members.		
6	Sec. 35.102. BIENNIAL REPORTS. (a) Not later than		
7	December 1 of each even-numbered year, the commission shall make a		
8	biennial report to the legislature. In the report, the commission		
9	shall recommend the proper salaries to be paid by the state for all		
10	justices and judges of the supreme court, the court of criminal		
11	appeals, the courts of appeals, and the district courts.		
12	(b) In recommending the proper salaries for all justices and		
13	judges of the supreme court, the court of criminal appeals, the		
14	courts of appeals, and the district courts, the commission shall		
15	consider the following factors:		
16	(1) the skill and experience required of the

2	by other public officials in the state, including:

6	(C) city attorneys in major metropolitan areas

8	(7) other factors that are normally or traditionally		
9	taken into consideration in the determination of judicial		
10	compensation; and		
11	(8) most importantly, the level of overall		
12	compensation adequate to attract the most highly qualified		
13	individuals in the state, from a diversity of life and professional		
14	experiences, to serve in the judiciary without unreasonable		
15	economic hardship and with judicial independence unaffected by		
16	financial concerns.		
17	SECTION 2. In appointing the initial members of the		
18	Judicial Compensation Commission, the governor shall appoint three		
19	persons to terms expiring February 1, 2009, three persons to terms		
20	expiring February 1, 2011, and three persons to terms expiring		

21 February 1, 2013.
