- 10 charged by the bureau of vital statistics, including the additional

- (i) A county clerk in a county with a population of 570,000
- or more and any part of which is located within the Lower Rio Grande
- 15 Valley adjacent to an international border may charge a fee for the
- 16 issuance of a certified copy of a birth certificate or death
- 17 certificate that exceeds the fee charged by the bureau of vital
- 18 statistics for the same type of certificate. A fee charged under
- 19 <u>this subsection may not exceed:</u>
- 20 <u>(1) for a birth certificate, \$2 more than the fee</u>
- 21 charged by the bureau of vital statistics; and
- 22 (2) for a death certificate, \$4 more than the fee

13	(h) A county that collects a fee under Subsection (g) shall

15	(1) \$2 of the fee for a birth certificate for the

17	(A) child abuse services; and
18	(B) health care for indigent children with
19	<pre>cancer;</pre>
20	(2) \$4 of the fee for a death certificate for the
21	county to use in providing burial services of indigent persons; and

25	SECTION 3. This Act takes effect immediately if it receives
