- 16 authority responsible for approving plats under those sections.
- 17 (c) Instead of the purpose described by Section
- 18 212.016(a)(10), an amended plat may be approved and issued by the
- 19 county to make necessary changes to the preceding plat to create six
- 20 or fewer lots in the subdivision or a part of the subdivision
- 21 covered by the preceding plat if:
- (1) the changes do not affect applicable county
- 23 regulations, including zoning regulations if the county has
- 24 authority to adopt zoning regulations; and

(2) the changes do not attempt to amend or remove any 1 2

covenants or restrictions.

SECTION 2. This Act takes effect immediately if it receives a vote of two-thirds of all the members elected to each house, as provided by Section 39, Article III, Texas Constitution. If this Act does not receive the vote necessary for immediate effect, this Act takes effect September 1, 2007.
