- relating to an optional fee on registration of a vehicle in certain counties to fund transportation projects.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Subchapter D, Chapter 502, Transportation Code,
- 6 is amended by adding Section 502.1725 to read as follows:
- 7 Sec. 502.1725. OPTIONAL COUNTY FEE FOR TRANSPORTATION
- 8 PROJECTS. (a) This section applies only to a county:
- 9 (1) that borders the United Mexican States;
- 10 (2) that has a population of more than 500,000; and
- 11 (3) in which the largest municipality has a population
- 12 of less than 300,000.
- 13 (b) The commissioners court of a county by order may impose
- 14 an additional fee, not to exceed \$10, for registering a vehicle in
- 15 the county.
- 16 (c) A vehicle that may be registered under this chapter
- 17 without payment of a registration fee may be registered in a county
- 18 imposing a fee under this section without payment of the additional
- 19 fee.

- 20 (d) A fee imposed under this section may take effect only on
- 21 January 1 of a year. The county must adopt the order and notify the
- department not later than September 1 of the year preceding the year
- 23 in which the fee takes effect.
- (e) A fee imposed under this section may be removed. The

- 1 removal may take effect only on January 1 of a year. A county may
- 2 remove the fee only by:
- 3 (1) rescinding the order imposing the fee; and
- 4 (2) notifying the department not later than September
- 5 <u>1 of the year preceding the year in which the removal takes effect.</u>
- 6 (f) The county assessor-collector of a county imposing a fee
- 7 under this section shall collect the additional fee for a vehicle
- 8 when other fees imposed under this chapter are collected. The
- 9 county shall send the fee revenue to the regional mobility
- 10 authority of the county to fund long-term transportation projects
- 11 <u>in the county.</u>
- 12 (g) The department shall collect the additional fee on a
- vehicle that is owned by a resident of a county imposing a fee under
- 14 this section and that, under this chapter, must be registered
- 15 <u>directly with the department. The department shall send all fees</u>
- 16 <u>collected for a county under this subsection to the regional</u>
- 17 mobility authority of the county to fund long-term transportation
- 18 projects in the county.
- 19 (h) The department shall adopt rules and develop forms
- 20 necessary to administer registration by mail for a vehicle being
- 21 registered in a county imposing a fee under this section.
- 22 SECTION 2. This Act takes effect immediately if it receives
- 23 a vote of two-thirds of all the members elected to each house, as
- 24 provided by Section 39, Article III, Texas Constitution. If this
- 25 Act does not receive the vote necessary for immediate effect, this
- 26 Act takes effect September 1, 2007.
