2-1 each odd-numbered year. On receipt of a request, the chief 2-2 appraiser shall certify a list by June 15 of all eligible 2-3 conservation and reclamation districts that are imposing taxes and 2-4 that participate in the district.
(1) If a vacancy occurs on the board of directors other than a vacancy in the position held by a county assessor-collector serving as a nonvoting director and other than a position filled by appointment under subsection (a-1), each taxing unit that is entitled to vote under Subsections (c)-(k) [by this section] may nominate by resolution adopted by its governing body a candidate to fill the vacancy. The unit shall submit the name of its nominee to the chief appraiser within 45 days after notification from the board of directors of the existence of the vacancy, and the chief appraiser shall prepare and deliver to the board of directors within the next five days a list of the nominees. The board of directors shall elect by majority vote of its members one of the nominees to fill the vacancy.

SECTION 2. The change in law made by this Act does not affect the right of a person serving on the board of directors of an appraisal district on the effective date of this Act to complete the person's term on the board.

SECTION 3. This Act takes effect September 1, 2007.
