## A BILL TO BE ENTITLED AN ACT

1-8 relating to the qualifications and selection of the board of directors of an appraisal district. 1-9

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

1-10 1-11 SECTION 1. Section 6.03, Tax Code, is amended by amending Subsections (a), (c), and (l) and adding Subsections (a-1), (a-2), (a-3), (a-4), and (a-5) to read as follows: 1-12 1-13

(a) The appraisal district is governed by a board of directors. Five directors are appointed by the taxing units that participate in the district as provided by <u>Subsections (c)-(k)</u> 1-14 1**-**15 1**-**16 1-17 [this section]. 1-18

(a-1) At least two positions on the board of directors must each be held by an individual who is not an officer or employee of a taxing unit that participates in the district or a former employee of a taxing unit that participates in the district who draws a pension from a participating taxing unit. If after the selection of five directors as provided by Subsections (c)-(k) there are not at least two directors who qualify under this subsection, the taxing units that participate in the district shall jointly appoint the necessary number of additional directors who are qualified under this subsection. A vacancy in a position for which a member is appointed under this subsection shall be filled in the same manner as the original appointment if it is necessary to fill the vacancy

to comply with the membership requirement of this subsection. (a-2) If the county assessor-collector is not appointed to the board, the county assessor-collector serves as a nonvoting director. The county assessor-collector is ineligible to serve if 1-31 1-32 1-33 1-34 the board enters into a contract under Section 6.05(b) or if the 1-35 commissioners court of the county enters into a contract under 1-36 Section 6.24(b).

1-37 (a-3) To be eligible to serve on the board of directors, an 1-38 individual other than a county assessor-collector serving as a 1-39 nonvoting director must be a resident of the district and must have resided in the district for at least two years immediately 1-40 1-41 preceding the date the individual takes office.

1-42 (a-4) An individual who is otherwise eligible to serve on 1-43 the board is not ineligible because of membership on the governing 1-44 body of a taxing unit. An employee of a taxing unit that participates in the district is not eligible to serve on the board 1-45 1-46 unless the individual is also a member of the governing body or an 1-47 elected official of a taxing unit that participates in the 1-48 district.

(a-5) An individual who has served for all or part of three consecutive terms on the board is ineligible to serve on the board during the term that begins on the next January 1 following the 1-49 1-50 1-51 1-52 third of those consecutive terms

1-53 (c) Members of the board of directors other than a county 1-54 assessor-collector serving as a nonvoting director and other than a member appointed under Subsection (a-1) are appointed by vote of the governing bodies of the incorporated cities and towns, the 1-55 1-56 school districts, and, if entitled to vote, the conservation and reclamation districts that participate in the district and of the 1-57 1-58 county.
