A BILL TO BE ENTITLED

AN ACT 1

- 2 relating to the protection and preservation of caves; providing
- 3 penalties.
- BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: 4
- 5 SECTION 1. Sections 201.011, 201.014, and 201.041, Natural
- 6 Resources Code, are amended to read as follows:
- Sec. 201.011. PERMIT REQUIRED. No person may excavate, 7
- remove, destroy, injure, alter in any significant manner, or deface 8
- any part of a cave owned by the State of Texas, unless the person 9
- possesses [he first obtains] a valid permit under Section 201.012 10
- [of this code]. 11
- 12 Sec. 201.014. PENALTIES. [(a)] A person who violates
- 13 Section 201.011 [of this code] is guilty of a Class \underline{A} [\underline{B}]
- 14 misdemeanor, unless the person has previously been convicted of
- violating that section, in which case the person is guilty of a 15
- 16 state jail felony.
- [(b) A person who violates Section 201.012 of this code is 17
- quilty of a Class C misdemeanor and the permit shall be revoked. 18
- Sec. 201.041. VANDALISM. (a) A person may not, without 19
- express, prior, written permission of the owner, [wilfully or] 20
- 21 knowingly:
- (1) break, break off, crack, carve upon, write, burn, 22
- 23 or otherwise mark upon, remove, or in any manner destroy, disturb,
- deface, mar, or harm the surfaces of any cave or any natural 24

- 1 material in a cave, including speleothems;
- 2 (2) disturb or alter in any manner the natural
- 3 condition of any cave; or
- 4 (3) break, force, tamper with, or otherwise disturb a
- 5 lock, gate, door, or other obstruction designed to control or
- 6 prevent access to any cave, even though entrance to the cave may not
- 7 be gained.
- 8 (b) A person who violates a provision of this section is
- 9 guilty of a state jail felony [Class A misdemeanor], unless the
- 10 <u>person</u> [he] has previously been convicted of violating this
- 11 section, in which case the person [he] is guilty of a felony of the
- 12 third degree.
- SECTION 2. Section 201.042(b), Natural Resources Code, is
- 14 amended to read as follows:
- 15 (b) A person who violates this section is guilty of a Class \underline{A}
- 16 [B] misdemeanor, unless the person has previously been convicted of
- 17 violating this section, in which case the person is guilty of a
- 18 state jail felony.
- 19 SECTION 3. The changes in law made by this Act apply only to
- 20 an offense committed on or after the effective date of this Act. An
- 21 offense committed before the effective date of this Act is covered
- 22 by the law in effect when the offense was committed, and the former
- 23 law is continued in effect for that purpose. For purposes of this
- 24 section, an offense was committed before the effective date of this
- 25 Act if any element of the offense was committed before that date.
- SECTION 4. This Act takes effect September 1, 2007.
