- 4 Notwithstanding Subsections (a) and (k), a person who 5 receives an exemption under Section 11.13, other than an exemption under Section 11.13(c) or (d) for an individual 65 years of age or 6 older, in a tax year is entitled to receive an exemption under 7 8 Section 11.13(c) or (d) for an individual 65 years of age or older in the next tax year on the same property without applying for the 9 10 exemption if the person becomes 65 years of age in that next year as 11 shown by:

- 19 <u>(m-1) Subsection (m) [This subsection</u>] does not apply if the 20 chief appraiser determines that the individual is no longer 21 entitled to any exemption under Section 11.13 on the property.
- SECTION 3. This Act takes effect immediately if it receives a vote of two-thirds of all the members elected to each house, as provided by Section 39, Article III, Texas Constitution. If this Act does not receive the vote necessary for immediate effect, this Act takes effect September 1, 2007.
