The Texas Department of Transportation shall 22 spend the money appropriated during the 76th Legislature for 23 Section 201.613, Transportation Code, as added by Chapter 1527, 24 Acts of the 76th Legislature, Regular Session, 1999, or money 25 received from the federal government to establish the border 26 inspection facilities under Section 201.613, Transportation Code, 27 as amended by this Act.

1 SECTION 3. This Act takes effect immediately if it receives 2 a vote of two-thirds of all the members elected to each house, as 3 provided by Section 39, Article III, Texas Constitution. If this 4 Act does not receive the vote necessary for immediate effect, this 5 Act takes effect September 1, 2007.
