SECTION 3. (a) Except as provided by Subsection (b) of this section, each law enforcement agency or other governmental entity required to issue identification cards under Subchapter H, Chapter 614, Government Code, as added by this Act, shall issue the cards not later than January 1, 2008.

(b) Each law enforcement agency that appoints or employs in the aggregate at least 1,000 full-time or part-time peace officers and reserve law enforcement officers shall issue the cards not later than January 1, 2010.

SECTION 4. This Act takes effect September 1, 2007.
