7	(d) The commissioner shall adopt criteria to require that at
8	least one program available under Subsection (a) be designed to
9	prevent and detect obesity and Type 2 diabetes by taking into
10	account the needs of school districts located in a county located on
11	the Texas-Mexico border that have a student population identified
12	by the commissioner as at risk for obesity and Type 2 diabetes. A
13	program designated under this subsection must provide that:
14	(1) each school district must distribute to each
15	school in the district:
16	(A) health curriculum teacher's guides for each
17	grade level;
18	(B) health curriculum student workbooks for each
19	student in each grade level;
20	(C) a physical education activity pad;
21	(D) a cafeteria program instructor's guide and
22	food service staff workbooks; and
23	(E) a newsletter for the family of each student

18	(b) In the first year a school district implements a program
19	under this section, the district shall report the measurements of
20	student height and weight and the progress of a student under the
21	program to the entity that administers the program. The
22	administering entity shall evaluate and analyze the measurements to
23	determine the effectiveness of the program in the first year.
24	SECTION 3. This Act takes effect immediately if it receives
25	a vote of two-thirds of all the members elected to each house, as
26	provided by Section 39, Article III, Texas Constitution. If this
27	Act does not receive the vote necessary for immediate effect, this
